Mr. Plemel gave background for members of the public regarding the updates discussed so far to Title 18 (Zoning) of the Carson City Municipal Code (CCMC), noting that the materials will remain online “for a couple of weeks” in order to receive public feedback. He also outlined the process of receiving comments from the Board of Supervisors and bringing them back to the Planning Commission. Mr. Plemel presented the Staff Report, incorporated into the record, which included reviewing Chapters 18.03 (Definitions) and 18.04 (Use Districts) of the CCMC and responded to clarifying questions. The Commissioners participated in discussion and made recommendations to Staff after which Mr. Plemel referenced the 2020 timeline below as next steps.
