**1. CALL TO ORDER AND DETERMINATION OF QUORUM**

(4:35:53) – Chairperson Boehmer called the meeting to order at 4:35 p.m. and read the public notice incorporated into the agenda pertaining to the Governor's COVID-19 emergency declaration. Roll was called, and a quorum was present.

**2. PLEDGE OF ALLEGIANCE**

(4:38:06) – Led by Member Thompson.

**3. PUBLIC COMMENT**

(4:38:35) – Chairperson Boehmer introduced the item. Chris Jasmine introduced himself as the president of the Traditional Archers of Nevada, a non-profit statewide organization, promoting traditional archery and traditional bow hunting. Mr. Jasmine noted that his organization has been working toward “traditional archery only mule deer tag quotas in the State,” informing County Advisory Boards should the item come up in future agendas. He clarified that their efforts were not to create additional archery seasons, but to

hunt during the established seasons, requesting 100 total additional tags, valid in any hunt with over 200 mule deer tags. Mr. Jasmine also responded to clarifying questions by the members.

#### **4. FOR POSSIBLE ACTION: ACTION ON APPROVAL OF MINUTES – April 28, 2020.**

(4:51:03) – Chairperson Boehmer introduced the item and entertained discussion or a motion. **Member Green moved to approve the April 28, 2020 meeting minutes as presented. The motion was seconded by Member Fleming and carried 5-0-0.**

#### **5. For Information Only: UPDATE AND ACTIVITY REPORT ON THE CARSON CITY URBAN WILDLIFE COMMITTEE.**

(4:51:49) – Chairperson Boehmer introduced the item and reported on a wildlife conservation project to build wood duck boxes, with area youth, and locating them along the Carson River, Deer Run Road, “and pretty much all over Carson County,” and at Walker River State Park. The project was in partnership with the Nevada Waterfowl Association and Ducks Unlimited. Chairperson Boehmer and Vice Chair Stewart also reported on deer born on the Capitol grounds. Discussion ensued regarding reptile season and the necessary precautions needed.

#### **6. For Information Only: UPDATE FROM THE CHAIR ON THE APRIL 10, 2020 NEVADA BOARD OF WILDLIFE COMMISSIONERS MEETING.**

(4:56:52) – Chairperson Boehmer introduced the item, reported on the May 1, 2020 Commission meeting and expressed disappointment that even though Carson and Douglas Counties had voiced their opinions on the recommendations to increase tag quotas in their hunt areas, their recommendations were not taken into considerations. He added that some tag quotas were even decreased throughout the State.

#### **7. CONSENT AGENDA:**

(5:01:11) – Chairperson Boehmer introduced the item and invited the Board to request the removal of items from the Consent Agenda for discussion. Member Green suggested discussion on item 7-C of the consent agenda. There were no other requests. Chairperson Boehmer entertained a motion.

**(5:03:43) – Member Thompson moved to accept the Consent Agenda with the exception of item 7-C. The motion was seconded by Vice Chair Stewart and carried 4-0-0.**

#### **7-A. DISCUSSION AND POSSIBLE ACTION TO MAKE RECOMMENDATIONS TO THE NEVADA BOARD OF WILDLIFE COMMISSIONERS REGARDING**

**COMMISSION GENERAL REGULATION 490, PARTY BONUS POINTS AND FIRST COME FIRST SERVE, LCB FILE NO. 103-19.** At its June 26, 2020 meeting, the Nevada Board of Wildlife Commission will hold a second workshop to consider a regulation relating to amending Chapter 502 of the Nevada Administrative Code (NAC). This regulation would allow children under 12 to purchase a bonus point if they turn 12 before the first day of the last season for that species. The regulation also addresses bonus points for sportsmen who apply as a party. Lastly, the regulation would allow a first-come-first-serve opportunity for returned tags that miss the 14-day deadline.

**7-B. DISCUSSION AND POSSIBLE ACTION TO MAKE RECOMMENDATIONS TO THE NEVADA BOARD OF WILDLIFE COMMISSIONERS REGARDING**

**COMMISSION GENERAL REGULATION 491, NOTIFICATION OF DRAW RESULTS.** At its June 26, 2020 meeting, the Nevada Board of Wildlife Commission will hold a workshop to consider a regulation amending Nevada Administrative Code (NAC) NAC 502.4208 relating to providing notification of draw results to clients who have opted out of having their results made public.

**7-C. DISCUSSION AND POSSIBLE ACTION TO MAKE RECOMMENDATIONS TO THE NEVADA BOARD OF WILDLIFE COMMISSIONERS REGARDING COMMISSION GENERAL REGULATION 492, THERMAL IMAGING OPTICS.** At its June 26, 2020 meeting, the Nevada Board of Wildlife Commission will hold a workshop to consider a regulation to consider amending Nevada Administrative Code (NAC) 503 and NAC 503.1485 relating to wildlife; prohibiting the use of certain night-vision equipment and devices for locating, hunting and taking game mammals and game birds; revising the definition of “trail camera or similar device”; and providing other matters properly relating thereto.

(5:04:15) – Chairperson Boehmer introduced the item. Member Green noted that the advances in technology, especially in radios, thermal devices, and trail cameras, have allowed many hunters and primarily “commercial outfits” to be able to “cheat.” The Board was in agreement that technology benefited out of state entities such as shed hunters as well. Chairperson Boehmer entertained a motion.

(5:12:08) – Member Green moved to accept and support the Department’s recommendation to the Commission. The motion was seconded by Vice Chair Stewart. Motion carried 5-0-0.

**7-D. DISCUSSION AND POSSIBLE ACTION TO MAKE RECOMMENDATIONS TO THE NEVADA BOARD OF WILDLIFE COMMISSIONERS REGARDING COMMISSION REGULATION 20-04 AMENDMENT #1, HERITAGE TAG VENDOR PROPOSALS.** At its June 26, 2020 meeting, the Nevada Board of Wildlife Commission will review the Wildlife Heritage Committee’s recommendations regarding Heritage Tag Vendor proposals for Fiscal Year 2021 and may take action.

**7-E. DISCUSSION AND POSSIBLE ACTION TO MAKE RECOMMENDATIONS TO THE NEVADA BOARD OF WILDLIFE COMMISSIONERS REGARDING COMMISSION REGULATION 20-12, 2020 - 2021 UPLAND GAME AND FURBEARER SEASONS AND BAG LIMITS.** At its June 27, 2020 meeting, the Nevada Board of Wildlife Commission will consider and may vote to amend regulations for upland game birds and mammals as well as furbearers for the 2020 season. This regulation will also include fall wild turkey seasons for 2020 and spring wild turkey seasons for 2021.

**7-F. DISCUSSION AND POSSIBLE ACTION TO MAKE RECOMMENDATIONS TO THE NEVADA BOARD OF WILDLIFE COMMISSIONERS REGARDING COMMISSION GENERAL REGULATION 485, TAG TRANSFER, DEFERENCE AND RETURN PROGRAM, LCB FILE NO. R022-19.** *At its June 27, 2020 meeting, the Nevada Board of Wildlife Commission will consider adopting a regulation relating to amending Chapter 502 of the Nevada Administrative Code (NAC). This regulation would provide direction for allowing the transfer, deference or return of tags under certain extenuating circumstances after the passage of Assembly Bill 404 of the 80<sup>th</sup> Legislative Session.*

**7-G. DISCUSSION AND POSSIBLE ACTION TO MAKE RECOMMENDATIONS TO THE NEVADA BOARD OF WILDLIFE COMMISSIONERS REVIEW AND CONSIDERATION OF POSSIBLE CHANGES TO WATERFOWL HUNT ZONES FOR 2021 – 2025.** *At its June 27, 2020 meeting, the Nevada Board of Wildlife Commission will consider recommendations and may choose to provide direction to the Department on possible changes to waterfowl hunting zones. The Pacific Flyway entertains changes to waterfowl hunting zones every five years, and potential changes must be noticed by July 1, 2020 to receive consideration. Any changes accepted by the Pacific Flyway will not take effect until the 2021 waterfowl seasons and would remain in effect until 2025.*

(5:13:03) – Chairperson Boehmer explained that a biologist from the Nevada Department of Wildlife had not been invited to discuss this item, adding that he had not been contacted by other County Advisory Boards or members of the public to change hunt zones. He was in agreement with the waterfowl hunting zones in the area and entertained input from the members who were also in agreement.

**8. DISCUSSION AND POSSIBLE ACTION TO MAKE RECOMMENDATIONS TO THE NEVADA BOARD OF WILDLIFE COMMISSIONERS REGARDING MANDATORY INDOCTRINATION / SEMINAR FOR BIGHORN RAM TAG HOLDERS.** *At its June 26, 2020 meeting, the Nevada Board of Wildlife Commission will provide a presentation on mandatory indoctrination/seminar for bighorn ram tag holders. The Commission may take action to require bighorn ram tag holders to complete an indoctrination class/seminar.*

(5:14:15) – Chairperson Boehmer introduced the item. Member Green noted that the instruction was only a 25-minute video and he was in support of it becoming mandatory. The Board members were in agreement and Chairperson Boehmer entertained a motion.

**(5:16:30) – Member Thompson moved to support the mandatory indoctrination/seminar for bighorn ram tag holders. The motion was seconded by Member Fleming and carried 5-0-0.**

**9. DISCUSSION AND POSSIBLE ACTION TO MAKE RECOMMENDATIONS TO THE NEVADA BOARD OF WILDLIFE COMMISSIONERS REGARDING HERITAGE PROJECT EXTENSION REQUESTS.** *At its June 26, 2020 meeting, the Nevada Board of Wildlife Commission will review Committee recommendations and may approve extension requests from projects approved in previous fiscal years.*

(5:16:56) – Chairperson Boehmer introduced both items (9-A and 9-B) and noted that they may be discussed and voted upon as one. There were no Board comments; therefore, Chairperson Boehmer entertained a motion.

**(5:18:28) – Member Thompson moved to support agenda items 9-A and 9-B. The motion was seconded by Member Green. Motion carried 5-0-0.**

**9-A. DISCUSSION AND POSSIBLE ACTION TO MAKE RECOMMENDATIONS TO THE NEVADA BOARD OF WILDLIFE COMMISSIONERS HERITAGE FUNDING REALLOCATION.** *At its June 26, 2020 meeting, the Nevada Board of Wildlife Commission will review Committee recommendations and may approve reallocation of any unused Heritage funds from previously approved projects to other previously approved projects from the same fiscal year.*

**9-B. DISCUSSION AND POSSIBLE ACTION TO MAKE RECOMMENDATIONS TO THE NEVADA BOARD OF WILDLIFE COMMISSIONERS UPDATE ON THE FALON NAVAL RANGE AND TRAINING CENTER AND NEVADA TEST AND TRAINING RANGE.** *At its June 27, 2020 meeting, the Nevada Board of Wildlife Commission will provide an update regarding the legislative environmental impact statements status and timelines for Commission consideration of congressional correspondence relative to wildlife impacts.*

(5:23:29) – Chairperson Boehmer introduced the item and gave background on the discussion and action taken by the Board a year ago. He also reiterated the Board's concern about the welfare of the wildlife in the area. Member Green mentioned that lung disease had also affected the area wildlife. Chairperson Boehmer noted he was neutral about the issue and entertained a motion in support or in opposition of the

item. It was recommended not taking action at the moment and hearing the discussion at the Commission meeting.

**14. Chairperson Boehmer was in favor of the proposed budget several meetings prior and entertained a motion in support of the previously discussed budget.

He also thanked Carl Lackey, wildlife biologist with the Nevada Department of Wildlife, for being on the call.
