B. PUBLIC COMMENTS

(3:02:37) – Chairperson Borders entertained public comments. Anna Coffrin introduced herself and stated that she wished to listen to the discussion on metal storage containers. Teresa Fozard introduced herself and spoke in favor of changing the Carson City Municipal Code to allow storage sheds “on a quarter acre or up and only a 20-foot [one] on anything less than an acre, and only one. And then on an acre or more, they could have a 20-foot or a 40-foot [storage shed] but only one as well, and they must be painted a neutral color that satisfies the City.”

(3:06:01) – Chairperson Borders introduced the item. Mr. Plemel provided background and noted the Commission will be reviewing Chapter 18.05 and the Development Standards Division 1, and may make recommendations to staff for possible amendments. He also noted that the final recommendations from these meetings will be presented to the Board of Supervisors at a future meeting for discussion only prior to returning to the Planning Commission for final review. Mr. Plemel invited the public to review all related documents on <https://carson.org/title18>.

(3:10:40) – Mr. Plemel reviewed the agenda materials incorporated into the record, received input from the Commissioners, and responded to clarifying questions.

(3:40:29) – During storage shed discussions, Ms. Fozard expressed concern that the City addressed issues and violations only if they received complaints. Ms. Coffrin explained that their mostly quarter-acre lot neighborhood has received “a lot of citations lately” adding that their yards are well-maintained, and the sheds are mostly used to store yard tools and equipment. She considered the sheds sturdy and not hazardous and was in favor of having them match the homes. Ms. Coffrin also explained that the neighbors who do not have sheds have not objected to them. Discussion ensued regarding building materials.

(4:58:40) – Mr. Plemel encouraged the public to provide comments to the Planning Division as the discussion continues at the November meeting. He also reviewed the upcoming tentative schedule:

- November 2, 2020: Planning Commission workshop, Development Standards Division 1 (Land Use and Site Design, continued if necessary) or Division 2 (Parking). He also reminded the Commission that the Workshop will take place in the Bob Boldrick Theater due to the construction in the Sierra Room.
