D. PUBLIC HEARING: ACTION ITEM

D-1 FOR POSSIBLE ACTION: DISCUSSION AND POSSIBLE ACTION REGARDING AN APPLICATION TO APPROVE A DINING ROOM WITH BEER AND WINE ONLY FOR CAPCITYSUSHI LLC DBA CAPITAL CITY SUSHI LOCATED AT 319 NORTH CARSON STREET, WITH BRADLEY ARMSTRONG AS THE LIQUOR MANAGER.

Mr. Plemel introduced the item, and Ms. Sullivan presented an overview of the Memorandum, which is incorporated into the record.

The Applicant, Bradley Armstrong, acknowledged that he understood and agreed to the Conditions of Approval outlined in the Memorandum and articulated by Ms. Sullivan. Ms. Sullivan informed Mr. Armstrong that he

could access the training course referenced with affidavit for his servers through the Partnership Carson City website.

ACTION: Mr. Plemel approved a Dining Room with Beer and Wine only for CapCitySushi LLC dba Capital City Sushi located at 319 North Carson Street, with Bradley Armstrong as the Liquor Manager subject to the following Conditions of Approval:

- Alcohol must come from approved sources.
- Changes to equipment or setup must be approved by the Health Authority.
- Business must adhere to FDA Food Code and NAC 446 for operational purposes.
- The Applicant must sign a sworn affidavit consistent with CCMC 4.13.060 regarding a server training course.

E. PUBLIC COMMENT

Mr. Plemel entertained public comments; however, none were forthcoming.
