SUBJECT: Liquor License: La Jeffa LLC., dba Antojitos La Jefa at 1701 N Carson Street, Carson City NV 89701 (Liquor - 005808-2020)

Recommendation: To approve an application for a Dining Room with Beer and Wine with Shams Mbaligh as the liquor manager for La Jeffa LLC, dba Antojitos La Jefa at 1701 N Carson Street, Carson City NV 89701, subject to the following approval:

1. The applicant must sign a sworn affidavit consistent with CCMC 4.13.060 regarding a server training course.
2. Alcohol served must come from approved sources.
3. Serving of Beer and Wine only.
4. No changes may be made without approval from health authority.
5. No beverage waste should be dumped in handwashing sinks.
6. Adherence to FDA Food Code and NAC 446 for operational purposes.

Per Carson City Municipal Code 4.13, all liquor license requests are to be reviewed by the Hearings Officer. The Hearings Officer may grant or deny the application for a liquor license or place conditions on a license to ensure compliance with the Municipal Code.

The subject request is to allow La Jeffa LLC, doing business as Antojitos La Jefa to have a Dining Room with Beer/Wine Liquor license with Shams Mbaligh as the liquor manager. The applicant has opened a restaurant. The business is located at 1701 N Carson Street.

This request has been reviewed by both the Health Department and the Sheriff's Office. The Health Department inspected the premises and is recommending approval based on the above conditions being met.

The Sheriff's office conducted a background check and did not find any disqualifying information based on CCMC 4.13.125.



The Sheriff's Office has conducted a background investigation on the above applicant for a liquor license and has found the following:


- **Background of premises:** Antojitos Le Jefa is located at 1701 N. Carson St which was previously occupied by Nationals Café. The business location was vacant and is now operating as Antojitos La Jefa. A business check was performed by CCSO Sgt. Smith on February 15th, who spoke to the onsite manager. Sgt. Smith provided information regarding the mandatory alcohol server training as well as providing contact information.
- **Financial arrangements:** Mr. Mobaligh and his brother Obaid Mobaligh own the business and have invested approximately \$10,000 of personal monies to open and establish the restaurant. They are leasing the property and building.
- **Method of operation:** Antojitos La Jefa serves Mexican style food and is open daily. Mr. Mobaligh employs personnel to run and manage the daily operations but will oversee the business. The restaurant will offer sales of beer and wine if approved.

- **Results of background:** The background for Shams Mabaligh consisting of DMV records, law enforcement agency checks, Nevada criminal history, credit report and fingerprint results from the state and FBI did not find any disqualifying information as listed in CCMC 4.13.125.




