Agenda Title: For Possible Action: Discussion and possible action regarding authority to purchase a Type 5 Apparatus for the Carson City Fire Department ("CCFD"), utilizing a joinder purchasing agreement through Washoe County with US Fire Equipment, LLC ("US Fire") for a total not to exceed amount of \$174,055.01. Staff Summary: At the last Board of Supervisors Meeting, the Board accepted an increase in a grant from the Nevada Division of Forestry ("NDF") for, among other things, the purchase of a new Type 5 Fire Apparatus for the CCFD Fuels Program. This item is for the purchase of that apparatus. The funds for the purchase of the apparatus will come wholly from the NDF grant.

Previous Action

On May 20, 2021 the Board of Supervisors approved an amended grant in the amount of \$1,995,289.01, for an increase of \$193,255.01 from the previously accepted amount, through the Nevada Division of Forestry ("NDF") from money appropriated by Senate Bill ("SB") 508 (2019), to fund hazardous fuel reduction projects in the Carson City wildland urban interface areas, including the purchase of a Type 5 Wildland Fire Engine.

On October 15, 2020, the Board of Supervisors unanimously approved the acceptance of the NDF SB508 grant award in the amount of \$1,802,034 to fund fuel reduction efforts.

Background/Issues & Analysis

Contract being utilized:

Washoe County Joinder Contract #3132-20 with an expiration date of 5/6/2023

The purchase price for the Type 5 Apparatus is \$165,428.01. Two additional options are requested: painted boxes and four extra B and D zone lights for \$5,927; and a sway bar link upgrade, slide tray, and storage baskets for \$2,700.00, for a total amount not to exceed \$174,055.01.


