3.A LU-2021-0183 For Possible Action: Discussion and possible action regarding a request for an Administrative Permit to allow for the construction of an accessory structure with a cumulative square footage totaling 66.4 percent of the size of the primary structure on property zoned Single Family 1 Acre (SF1A) located at 4180 Muldoon Street (Heather Ferris, hferris@carson.org)

Summary: The applicant is proposing construction of an accessory building which will include a garage and guest building totaling 2,589.6 square feet. A guest building and a garage are permitted accessory uses in the Single Family 1 Acre zoning district; however, Carson City Municipal Code (CCMC) 18.05.055 requires approval of an Administrative Permit if the cumulative square footage of the accessory structures on-site are more than 50%, but less than 75% of the square of the primary structure.

Comments may be limited to three minutes per person or topic at the discretion of the Administrative Hearing Examiner in order to facilitate the meeting.*
