3.A LU-2021-0183 FOR POSSIBLE ACTION: DISCUSSION AND POSSIBLE ACTION REGARDING A REQUEST FOR AN ADMINISTRATIVE PERMIT TO ALLOW FOR THE CONSTRUCTION OF AN ACCESSORY STRUCTURE WITH A CUMULATIVE SQUARE FOOTAGE TOTALING 66.4 PERCENT OF THE SIZE OF THE PRIMARY STRUCTURE ON PROPERTY ZONED SINGLE FAMILY 1 ACRE (SF1A) LOCATED AT 4180 MULDOON STREET.

Ms. Sullivan introduced the item, and Ms. Ferris indicated that there were no changes to the Staff Report, which is incorporated into the record.

The Applicant, Chris Fredlund, confirmed that he had read and agreed to the Conditions of Approval outlined in the Staff Report. Mr. Fredlund clarified for the record that the bedroom and bath separated from the rest of the dwelling by the RV garage was for his son to eventually move

into as well as for a “backup space.” Mr. Fredlund confirmed that the request involved only one guest house.
