1. CALL TO ORDER AND DETERMINATION OF QUORUM

(4:36:55) – Chairperson Green called the meeting to order at 4:36 p.m. Roll was called, and a quorum was present.

2. PLEDGE OF ALLEGIANCE

(4:37:53) – Led by Vice Chairperson Thompson.

3. PUBLIC COMMENT

(4:38:21) – Kevin “CK” Bailly introduced himself and thanked the Carson City Parks and Recreation Department staff as well as the Board for repairing and resetting the floating Americans with Disabilities Act (ADA) fishing platform at Bailly Fishing Pond. He also wished to thank Paramount Iron and Handrail, Inc., Newt Concrete Construction, and Connolly Crane Service as well as Carson City Parks, Recreation, and Open Space Director Jennifer Budge, Carson City Parks Superintendent Dave Navarro, Jr., Carson City Parks Operations Manager Dan Kastens, Carson City Park Maintenance Worker Bill Anderson,

Carson City Parks Operations Coordinator John Doran, and Nevada Department of Wildlife (NDOW) Biologist Chris Burkhard.

(4:41:47) – Chairperson Green commented that “what we had to do as a board over the past year has been a disaster.” He stated that he would not have kept the public “out” of the meetings if he could do something different, as the Members did not know when members of the public were on the conference phone line unless they made it known, and, according to the mandate, the Board only had to take public comment at the beginning and the end of the meetings. He believed the mandate excluded the public and noted that a WAB meeting was canceled due to the inability to get the conference phone line open for public comments. He added that virtual meetings can come with multiple problems.

4. FOR POSSIBLE ACTION: ACTION ON APPROVAL OF MINUTES – MAY 3, 2021.

(4:44:47) – Chairperson Green introduced the item and entertained a motion.

(4:44:56) – Vice Chairperson Thompson moved to approve the May 3, 2021 meeting minutes as presented. The motion was seconded by Member Fleming and carried 4-0-0.

(4:45:26) – Chairperson Green introduced the item and reported on the May 7 and 8, 2021 Nevada Board of Wildlife Commissioners meeting, which was held remotely via Zoom.

(4:59:01) – Chairperson Green introduced the item and entertained requests to pull items from the Consent Agenda. Vice Chairperson Thompson wished to pull items 7-A and 7-F. There were no other requests.

(5:01:14) – Member Fleming moved to accept the Consent Agenda recommendations with the exception of items 7-A and 7-F. The motion was seconded by Member Stewart and carried 4-0-0.

7-A. DISCUSSION AND POSSIBLE ACTION TO OFFER COMMENT TO THE NEVADA BOARD OF WILDLIFE COMMISSIONERS REGARDING THE LITIGATION REPORT. *At its June 25, 2021 meeting, a Deputy Attorney General will present to the Nevada Board of Wildlife Commissioners a report on litigation, as an informational item. The CCCABMW may desire to offer public comment on the litigation.*

(5:01:43) – Chairperson Green introduced the item. Vice Chairperson Thompson informed the Board that the Carson Lake area was transferred over from the Bureau of Reclamation and the Bureau of Land Management (BLM) to the State to be managed by NDOW, and he requested that the Board comment in support of the continuation of litigation to fight for the water rights “to get enough water into the [Carson Sink] to maintain its current status as a major migratory spot for various waterfowl and migratory birds.” Chairperson Green agreed with Vice Chairperson Thompson’s statement.

(5:05:31) – Vice Chairperson Thompson moved to approve a comment by Chairperson Green on behalf of the WAB regarding the concern about the continuation of the waterflow into the Carson Sink area to keep that viable hunting area. The motion was seconded by Member Fleming and carried 4-0-0.

7-B. DISCUSSION AND POSSIBLE ACTION TO OFFER COMMENT TO THE NEVADA BOARD OF WILDLIFE COMMISSIONERS REGARDING THE LEGISLATIVE UPDATE REPORT. *At its June 25, 2021 meeting, a report will be provided to the Nevada Board of Wildlife Commissioners on the final Legislative Committee Meeting and Legislative session update. The CCCABMW may desire to offer public comment on the Legislative Report.*

7-C. DISCUSSION AND POSSIBLE ACTION TO MAKE RECOMMENDATIONS TO THE NEVADA BOARD OF WILDLIFE COMMISSIONERS REGARDING RECOVERING AMERICA’S WILDLIFE ACT. *At its June 25, 2021 meeting an update will be provided on Recovering America’s Wildlife Act, H.R. 2773, a bipartisan act that, if passed, would provide up to \$1.3 Billion in funding to fully conserve Species of Greatest Conservation need and fully implement state Wildlife Action Plans.*

7-D.
