##### **D-1. CARSON CITY**

(1:35:51) – Chairperson Hataway introduced the item. Ms. Russell presented the agenda materials and responded to clarifying questions.

##### **D-2. CARSON CITY SCHOOL DISTRICT**

(1:45:01) – Chairperson Hataway introduced the item. Carson City School District Chief Financial Officer Andrew Feuling introduced himself and presented the agenda materials. He also responded to clarifying questions.

(1:55:07) – Chairperson Hataway introduced the item and recommended that the Commission set the limit at 10 percent for the limitation on total ad valorem tax levy.

**(1:55:48) – MOTION: Commissioner Sanada moved to set the limit at 10 percent. Commissioner Varner seconded the motion. The motion carried 4-0-0.**

**(1:56:35) – MOTION: Commissioner Varner so moved. Vice Chairperson Providenti seconded the motion. The motion carried 4-0-0.**
