**AGENDA ITEM 4.C:** For Possible Action: Discussion and possible action regarding an application to approve a Packaged Liquor License (LIQUOR-006730-2021) with Yahaira A. Wagner as the liquor manager for Rand Avenue Convenience Store located at 1800 E William St. #14 & #12, Carson City, NV 89701.

**Recommendation:** To approve an application for a Packaged Liquor License with Yahaira A. Wagner as the liquor manager for M.Y MACIAS GOMEZ, LLC dba Rand Avenue Convenience Store at 1800 E William St. #14 & #12, Carson City, NV 89701 subject to the following approval:

1. The applicant must sign a sworn affidavit consistent with Carson City Municipal Code (CCMC) 4.13.060 regarding a server training course.
2. Alcohol sold must come from approved sources.
3. The owner of the liquor license must maintain on the premises, evidence of employee server training certification for all employees that serve or sell alcohol.
4. Only packaged alcohol permitted for sale at this time.

Per CCMC 4.13, all liquor license requests are to be reviewed by the Hearings Officer. The Hearings Officer may grant or deny the application for a liquor license or place conditions on a license to ensure compliance with the Municipal Code.

The subject request is for M.Y MACIAS GOMEZ, LLC dba Rand Avenue Convenience Store to have a Packaged Liquor license with Yahaira A. Wagner as the liquor manager. The business is a convenience store that was recently purchased and has been operating under the previous owner's liquor license (LIQUOR-004839-2020) with an interim management agreement. The business is located at 1800 E William St. #14 & #12, license number BL-006729-2021.

The Sheriff's office did an inspection of said location on 12/22/2021 and conducted a background check and did not find any disqualifying information based on CCMC 4.13.125.

This request has been reviewed by the Health Department. The Health Department inspected the premises and is recommending approval based on the above conditions being met.

WHEREAS, on 9/29/, 2021, it has come to the attention of BUYER that Seller is married to SERGIO CASTAÑEDA, an individual who has assisted in the ongoing operation of the liquor/retail and wholesale merchandise store location that is the subject of the Asset Purchase Agreement (the "Agreement") referenced hereinabove.

WHEREAS FURTHER, SERGIO CASTAÑEDA, has stated he was interested in opening a liquor/retail and wholesale merchandise store within the "non-compete" area and time period when this purchase is final. A complete violation and breach the Agreement.

NOW, THEREFORE, the undersigned, by executing this document, hereby agree that neither of them, OLIVIA G. OCHOA and/or SERGIO CASTAÑEDA, will open or operate a liquor/retail and/or wholesale merchandise convenience store within Carson City, or a fifteen (15) mile radius of the current location for a period of three (3) years from the date of Closing.

WHEREAS, the parties hereto, by executing this document, hereby amend the Asset Purchase Agreement Article VIII, by adding Section 8.75 follows:

**ARTICLE VIII**

**OBLIGATIONS FOLLOWING CLOSING; NON-COMPETE, TRAINING AND LIQUOR LICENSE**

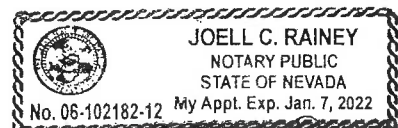

The Sheriff's Office has conducted a background investigation on the above applicant as the liquor manager for the Rand Ave. Convenience Store.

- **Background of premises:** The Rand Ave. Convenience Store is located at 1800 E. William St. and is being sold by the current owner who has operated the store since 2006. During the course of their ownership the store was cited four times for selling to minors from 2007-2015. The sale of the business and transition to the new owners was expected to take place sometime in November.
- **Financial arrangements:** Yahaira Wagner and her mother Marina Macias Gomez are purchasing the business consisting of inventory, fixtures, and equipment for the sum of \$150,000. The purchase is being funded by Marina Macias Gomez and is being paid in cash from personal monies. The monthly lease was being negotiated at or around \$2300.00.
- **Method of operation:** The Rand Ave. Convenience Store is open daily selling tobacco, food, clothing, and other sundries as well as packaged beer, wine, and liquor. Marina Macias Gomez will be managing and working in the store full time and Ms. Wagner who is employed in Reno, plans on being in the store several times a week.
- **Results of background:** The background for Yahaira Anali Wagner, consisting of DMV records, local agency checks, Nevada criminal history query, credit report and fingerprint responses did not find any disqualifying information based on CCMC 4.13.125.
