**Staff Summary:** On January 13, 2021, CAMPO elected Commissioner Greg Stedfield and Mayor Lori Bagwell to serve as its Chairperson and Vice-Chairperson, respectively, for a term of two years. Mr. Stedfield's final meeting as a member of CAMPO was December 8, 2021; therefore, CAMPO needs a new Chairperson to serve the second half of his two-year term. Mayor Bagwell's two-year term as Vice-Chairperson has not expired, and CAMPO would only be required to elect a new Vice-Chairperson if she is elected CAMPO's new Chairperson. Any member of CAMPO may hold either of these positions. Terms of the newly elected Chairperson (and Vice-Chairperson, if applicable) will commence immediately.

**5-B For Possible Action** – Discussion and possible action regarding a formal amendment to the Carson Area Metropolitan Planning Organization's ("CAMPO") Federal Fiscal Year ("FFY") 2021-2024 Transportation Improvement Program ("TIP") to (1) regarding the East William Street Complete Streets Project, program \$9.3 million in Rebuilding American Infrastructure with Sustainability and Equity ("RAISE") Grant funds, program \$8,144,491 in local funding, and delete \$10,839,213 in FFY 2025 unspecified funds; (2) add a project for Jump Around Carson ("JAC") transit operations and program \$421,296 in Federal Transit Administration ("FTA") FFY 2021 Section 5307 Apportionment Grant funds; and (3) closeout four completed projects.

**Staff Summary:** The proposed amendment to CAMPO's FFY 2021-2024 TIP will program a total of \$17,444,491 in federal and local funding into the East William Street Complete Street Project, program \$421,296 in FTA Section 5307 funding for JAC transit operations as part of the American Rescue Plan Act ("ARPA"), and closeout four projects that were completed in prior fiscal years.

(4:31:12) – Chairperson Stedfield introduced the item. Mr. Martinovich introduced Kevin Verre, Assistant Chief, Program Development with the Nevada Department of Transportation (NDOT). Mr. Verre reviewed a PowerPoint presentation, incorporated into the record, which explained the Federal Fiscal Year (“FFY”) 2022-2025 Statewide Transportation Improvement Program (“STIP”) and the One Nevada Process for project prioritization and harmonization. He also responded to clarifying questions by the Board members, and explained to Vice Chair Bagwell that prioritization would take place twice-per -year and the needs evaluation annually, who stressed the importance of preventing loss of life as important, and Ex-Officio Member Rosenberg clarified that safety was rated highest and top priority. Member Henderson believed “we need to do something regarding safety on US 50, sooner rather than later.” Mr. Verre explained that portable message signs were being worked on currently. This item was not agendized for action.

(5:02:44) – Chairperson Stedfield introduced the item. Mr. Cruz presented the proposed changes to the CAMPO Policies and Procedures, incorporated into the record as late material, and responded to clarifying questions by the members.

### **Background/Issues & Analysis**

#### **Chairperson Position:**

The term of Commissioner Stedfield's membership in CAMPO expired on December 31, 2021, at which time he was one year into a two-year term serving as CAMPO's Chairperson. CAMPO will consider the nomination and election of a new Chairperson to serve the remaining year of that two-year term.

Any member of CAMPO may hold the Chairperson position.

#### **Vice-Chairperson Position:**

On January 13, 2021, CAMPO elected Mayor Bagwell to serve as its Vice-Chairperson through calendar year 2022. Therefore, Mayor Bagwell's term as Vice-Chairperson will not expire until December 31, 2022. However, in the event that Mayor Bagwell is elected to serve as Chairperson for the remainder of 2022, CAMPO would need to select a new Vice-Chairperson. If anyone other than Mayor Bagwell is elected to serve as CAMPO's Chairperson for 2022, then there is no need to disturb Mayor Bagwell's unexpired term as Vice-Chairperson.

Any member of CAMPO may hold the Chairperson position.

**City Policy on Chairperson and Vice-Chairperson Elections:**

An aspirational goal within the City's Policies and Procedures for Boards, Committees, and Commissions encourages leadership to rotate regularly among members. Additionally, nomination of a previous chairperson should be considered only after two years has passed since he/she last served.

Staff recommends a one-year term for the newly elected Chairperson (and Vice-Chairperson, if applicable), commencing immediately and expiring December 31, 2022.

## Minutes of the January 13, 2021 Meeting

### Page 3

(4:50:50) – Chairperson Stedfield introduced the item. Ms. Maloney presented the Staff Report, and highlighted key takeaways from the accompanying PowerPoint presentation and attached exhibits such as the Fiscal Years 2021-2022: July 1, 2020 – June 30, 2022 Unified Planning Work Program which was Approved on May 13, 2020, all of which are incorporated into the record. She noted that the purpose of the presentations was to provide the CAMPO board and the public a better understanding of the long-range planning efforts undertaken by CAMPO and Staff, and how these planning efforts influence development decisions and promote an efficient regional transportation network. Chairperson Stedfield called Staff “capable and qualified” and thanked them for “bringing their A-game at every meeting.” This item was not agendized for action.

### **6-C FOR POSSIBLE ACTION – DISCUSSION AND POSSIBLE ACTION REGARDING CAMPO’S 2050 REGIONAL TRANSPORTATION PLAN.**

(5:11:36) – Chairperson Stedfield introduced the item. Dirk Goering, Senior Transportation Planner, presented the 2050 Regional Transportation Plan (RTP), incorporated into the record, and responded to clarifying questions. Vice Chair Bagwell inquired about increasing the size of the Fifth Street roundabout for safety reasons, citing the expansion of Eagle Valley Middle School, adding that “that whole area is constrained by one road.” Mr. Goering noted that Staff would follow the Board’s recommendation, should they decide to make it part of the motion. Ms. Maloney advised updating the project description to include language about capacity or operational enhancements to the roundabout to clarify the project’s eligibility for federal funds. She also recommended that Staff add the anticipated expenditure to the project, noting that Staff had “their eye on [the roundabout].” Vice Chair Bagwell reminded the Board that Lyon County commuters have been using Fairview Drive and wanted to make certain the roundabout was a safe route to the middle school. She was in favor of having one like that on Stewart and South Carson Streets. Chairperson Stedfield entertained additional discussion and when none was forthcoming, a motion.

**(5:34:36) – Vice Chair Bagwell move to approve CAMPO’s 2050 Regional Transportation Plan as submitted, with an update to Project CC1 to clarify that the project would include operational and/or capacity improvements at the Fifth Street/Fairview Drive roundabout, funding permitted. The motion was seconded by Member Schuette.** Ms. Maloney recommended clarifying the revision of the footnote on Table 5 “as described by Staff on the record.” Both the mover and seconder accepted the amendment. Member Macquarie recommended adding to the project a sidewalk on the south side of Carson River Road to Eagle Valley Middle School. Ms. Maloney clarified that Complete Street Elements between Fairview Drive and the eastern extent would cover his request, but it did not need to be included in the RTP. **The motion carried 7-0-0.**

(5:38:31) – Chairperson Stedfield entertained Board comments. Vice Chair Bagwell welcomed the new Board members. Ex-Officio Member Rosenberg also welcomed the new members, particularly Member Terry with whom she had worked closely for many years.

**Agenda Title: For Possible Action** – Discussion and possible action regarding a formal amendment to the Carson Area Metropolitan Planning Organization’s (“CAMPO”) Federal Fiscal Year (“FFY”) 2021-2024 Transportation Improvement Program (“TIP”) to (1) regarding the East William Street Complete Streets Project, program \$9.3 million in Rebuilding American Infrastructure with Sustainability and Equity (“RAISE”) Grant funds, program \$8,144,491 in local funding, and delete \$10,839,213 in FFY 2025 unspecified funds; (2) add a project for Jump Around Carson (“JAC”) transit operations and program \$421,296 in Federal Transit Administration (“FTA”) FFY 2021 Section 5307 Apportionment Grant funds; and (3) closeout four completed projects.

**Staff Summary:** The proposed amendment to CAMPO’s FFY 2021-2024 TIP will program a total of \$17,444,491 in federal and local funding into the East William Street Complete Street Project, program \$421,296 in FTA Section 5307 funding for JAC transit operations as part of the American Rescue Plan Act (“ARPA”), and closeout four projects that were completed in prior fiscal years.

### Proposed Motion

I move to formally amend CAMPO’s Federal Fiscal Year 2021-2024 Transportation Improvement Program as presented.

### Background/Issues & Analysis

CAMPO is responsible for carrying out transportation planning activities within the Carson Metropolitan Planning Area. The TIP document is developed in collaboration with Carson City, Douglas County, Lyon County, and the Nevada Department of Transportation (“NDOT”). The projects within the TIP are consistent with CAMPO’s adopted goals and are anticipated to contribute to meeting CAMPO’s performance targets. The adopted goals and performance targets are contained within CAMPO’s 2050 Regional Transportation Plan (“RTP”), available at <https://www.carson.org/government/departments-g-z/public-works/transportation/campo-carson-area-metropolitan-planning-organization>. All projects programmed within the TIP are financially constrained, meaning funding is reasonably anticipated to be available, as documented within the 2050 RTP.

TIP amendments are required for the following actions:

- Adding a new project, or;
- Significantly changing a project (by scope or cost).

This proposed formal amendment (amendment 21-09) will amend the following projects:

- CC20210005 - Program \$9,300,000 in RAISE Grant funds and \$8,144,491 in local funding into the FFY 2023 Construction Phase of the East William Street Complete Street Project, for a project total of \$17,444,491. Delete \$10,839,213 of “Unspecified” placeholder funds from FFY 2025. The project cost increased \$6,605,278.
- CC20210019 - Program \$421,296 in FTA FFY 2021 Section 5307 apportionment funding received as part of the ARPA for JAC transit operations. The apportionment does not require a local match.
- Closeout four completed projects. There are no changes to the prior funding of these projects. The four project are:
  - CC20140017 - I-580 Carson City Roadway Rehabilitation (NDOT)
  - CC20180009 - Fairview Drive Reconstruction
  - CC20180014 - Airport Road Sewer & Road Project
  - CC20200005 - Northridge Drive Reconstruction Project

Formal TIP amendments require a 14-day public comment period as described in CAMPO’s Public Participation Plan. The public comment period for this action opened on December 25, 2021 and ended on January 8, 2022. No public comment has been received at this time, and any received after publication of the January 12, 2022 CAMPO agenda will be provided as late material.

Explanation of Fiscal Impact: The TIP is a federally-required document that programs funding for projects that are of a regional significance and/or are funded with federal transportation funding. This document does not commit CAMPO’s or a local jurisdiction’s funding. Future agreements between NDOT and local jurisdictions will commit funding and resources.

The fiscal impact associated with this item is for staff time to administer the TIP. CAMPO’s Unified Planning Work Program (“UPWP”) tasks are reimbursable with federal planning funds at a rate of 95%. The 5% local match has been budgeted within CAMPO’s approved Fiscal Years 2021 & 2022 UPWP, Work Element 1.0, MPO Administration.



## Purpose

The Transportation Improvement Program (TIP) is a short-term programming document to prioritize transportation improvement projects over a four-year period. The TIP is a federally required document and allows for the obligation of federal funds. The TIP is developed and formally adopted by the Carson Area Metropolitan Planning Organization (CAMPO). CAMPO is responsible for carrying out transportation planning activities within the Metropolitan Planning Area (MPA), shown in Figure 1.

**Figure 1: CAMPO MPA Boundary**



The TIP document is developed in collaboration with Carson City, Douglas County, Lyon County, and the Nevada Department of Transportation (NDOT). The Projects within the TIP are consistent with CAMPO's adopted goals and are anticipated to contribute to meeting CAMPO's performance targets. The adopted goals and performance targets are contained within CAMPO's 2050 long-range Regional Transportation Plan (RTP), available at <https://www.carson.org/government/departments-g-z/public-works/transportation/campo-carson-area-metropolitan-planning-organization>. All projects programmed within the TIP are financial constrained as documented within the 2050 RTP.

The TIP is required to be updated at least every four years. Transportation projects which are federally funded and are of regional significance must be in the TIP. Any changes to the project implementation schedule, funding, or description require an Administrative Amendment or a Formal Amendment to the TIP. All amendments are listed on the cover page. The execution of amendments and any required public noticing is performed in compliance with CAMPO's [Public Participation Plan](#).

## eSTIP

The eSTIP, which stands for the Electronic State Transportation Improvement Program, is a searchable database that can be filtered based on project criteria. This online platform was developed by the Nevada Department of Transportation, in coordination with Nevada's four Metropolitan Planning Organizations.

Changes to the projects are in real-time so users can find the most up-to-date information. Project details and customized reports are available on the eSTIP website, at <https://estip.nevadadot.com>.

The eSTIP categorizes transportation projects by five general categories: roadway, transit, bicycle and pedestrian, environmental, or other. Project funding is scheduled by Federal Fiscal Year (October 1<sup>st</sup> through September 30<sup>th</sup>) and organized into four potential phases: preliminary engineering (PE), right-of-way (ROW), construction, and other. Information from the eSTIP website on funding sources is provided below for reference.

Project details for all projects formally incorporated into CAMPO's 2021-2024 TIP are provided in Appendix A (attached).
