5. Public Meeting Item(s):

5-A For Possible Action – Discussion and possible action regarding the East William Complete Streets Feasibility Study ("Study") and its potential use to guide the design and construction of the East William Complete Streets Project ("Project").

Staff Summary: Staff will present the results of the Study, which provides information on the Project, which comprises potential complete street improvements along East William Street between

North Carson Street and the I-580/U.S. Highway 50 interchange, including pavement reconstruction and preservation, utility replacement, safety enhancements, and multi-modal transportation infrastructure. The Study is funded through CAMPO's Unified Planning Work Program ("UPWP").

5-B For Possible Action – Discussion and possible action regarding a formal amendment to the Carson Area Metropolitan Planning Organization's ("CAMPO") Federal Fiscal Year ("FFY") 2021-2024 Transportation Improvement Program ("TIP") to (1) program \$1.1 million in Congressionally Designated Spending ("CDS") appropriations, plus \$950,000 of local funding, for the Appion Way Traffic Signal and Intersection Improvement Project; (2) program \$595,266 in Transportation Alternatives Program ("TAP") funding, plus \$31,330 in local funding, for the Western Nevada Safe Routes to School Program; (3) program \$950,000 of Highway Safety Improvement Program ("HSIP") funding, plus \$65,000 of State Gas Tax funding, for the installation of wrong way driver warning systems on I-580 and (4) closeout the completed Center Drive Road Rehabilitation Project.

Staff Summary: The proposed amendment to CAMPO's FFY 2021-2024 TIP will close out one project and program a total of \$2,645,266 in federal funds, \$65,000 in State funds, and \$981,330 in local funds across three transportation projects.

(4:36:42) – Member Novak moved to approve the minutes of the CAMPO May 11, 2022 meeting as presented. The motion was seconded by Vice Chair Schuette and carried 6-0-0.

5-A FOR POSSIBLE ACTION – DISCUSSION AND POSSIBLE ACTION REGARDING (1) AMENDMENT 1 (“AMENDMENT”) TO COOPERATIVE AGREEMENT NO. P301-19-804 (“ORIGINAL CONTRACT”) WITH THE NEVADA DEPARTMENT OF TRANSPORTATION (“NDOT”) CHANGING THE PROJECT END DATE FOR THE CARSON AREA TRANSPORTATION SYSTEM MANAGEMENT PLAN (“CATSMP”) FROM JUNE 30, 2022, TO JUNE 30, 2023; AND (2) AUTHORITY FOR THE TRANSPORTATION MANAGER TO SIGN THE AMENDMENT AND FUTURE AMENDMENTS TO THE ORIGINAL CONTRACT THAT EXTEND THE TIME FOR PERFORMANCE.

(4:37:00) – Chairperson Bagwell introduced the item and entertained disclosures. Vice Chair Schuette read into the record a prepared disclosure statement, advised of no disqualifying conflict of interest, and noted that she would participate in discussion and action.

(4:38:16) – Mr. Martinovich presented the Staff Report and accompanying documentation, all of which are incorporated into the record. He requested the extension of Amendment 1 to Cooperative Agreement No. P301-19-804 with the Nevada Department of Transportation (NDOT), changing the project end date for the Carson Area Transportation System Management Plan (CATSMP) from June 30, 2022, to June 30, 2023. He also responded to clarifying questions. Chairperson Bagwell expressed concern regarding future extensions and believed that they should be discussed and approved by the CAMPO Board. There were no public comments; therefore, Chairperson Bagwell entertained a motion.

(4:43:25) – Member Novak moved to approve Amendment No. 1 as presented and to authorize the Transportation Manager to sign the Amendment that extends the time for performance under the Original Contract. The motion was seconded by Member Dodson and carried 6-0-0.
