A regular meeting of the Carson City Advisory Board to Manage Wildlife was scheduled for 6:00 p.m. on Monday, May 10, 2004 in the City Hall Capitol Conference Room, 201 North Carson Street, Carson City, Nevada.

1. CALL TO ORDER, DETERMINATION OF QUORUM (1-0007) - Vice Chairperson Yanuck called the meeting to order at 6:02 p.m. A quorum was present. Chairperson Walker was absent.

2. APPROVAL OF MINUTES - April 5, 2004 (1-0014) - Member Clyde moved to approve the minutes. Member Derley seconded the motion. Motion carried 4-0.

3. MODIFICATIONS TO THE AGENDA (1-0023) - None.

4. PUBLIC COMMENT ON NON-AGENDIZED ITEMS (1-0027) - None.

5. DISCLOSURES (1-0038) - None.

6. DISCUSSION AND ACTION TO SCHEDULE A JOINT MEETING OF THE PARKS AND RECREATION COMMISSION AND THE CARSON CITY ADVISORY BOARD TO MANAGE WILDLIFE TO REVIEW THE U.S. FOREST SERVICE CLEAR CREEK / KINGS CANYON LANDSCAPE ANALYSIS AND STRATEGY (1-0043) - Mr. Krahn provided background information on this item, and on the U.S. Forest Service ("USFS") Clear Creek / Kings Canyon Landscape Analysis and Strategy. He reviewed highlights of the landscape analysis report and its correlation to the Board. He responded to questions, and discussion took place regarding the origin, purpose, and scope of the landscape analysis. In response to an additional question, he provided an overview of the format for the joint meeting. NDOW Wildlife Biologist Carl Lackey expressed an interest in attending the joint meeting and Ms. King committed to advising him of the meeting date. **Member Zuber moved to schedule a joint meeting with the Parks and Recreation Commission. Member Derley seconded the motion. Motion carried 4-0.** Mr. Krahn advised that the USFS will conduct its own public meeting process for the landscape analysis. Vice Chairperson Yanuck thanked Mr. Krahn for his presentation.

7. PRESENTATION, DISCUSSION AND ACTION REGARDING NEVADA DEPARTMENT OF WILDLIFE BIG GAME QUOTA RECOMMENDATIONS FOR THE 2004/2005 HUNTING SEASONS (1-0500) - Vice Chairperson Yanuck introduced NDOW Wildlife Biologist Carl Lackey and discussion took place regarding the method by which to review the quota recommendations. Mr. Lackey reviewed the recommendations, by species, as outlined in the quota recommendation handbooks which

were previously provided to the Board members. Mr. Lackey reviewed details of the redistribution of responsibilities following the recent retirement of Wildlife Biologist Walter Mandeville. Vice Chairperson Yanuck called for questions or comments from the Board members and from the public; however, none were provided. Discussion took place regarding the appropriate action, and **Member Clyde moved to accept the quota recommendations, as submitted. Member Zuber seconded the motion. Motion carried 4-0.** Vice Chairperson Yanuck thanked Mr. Lackey for his presentation.

8. DISCUSSION AND POSSIBLE ACTION TO RECOMMEND ESTABLISHING A WILDLIFE COMMISSION SUBCOMMITTEE TO REVIEW THE MATTER OF OHV USE AND TO DEFINE THE SCOPE OF WORK AND TIMETABLE FOR SAID SUBCOMMITTEE (1-1179)- Vice Chairperson Yanuck provided background information on this item, and requested input from the Board members. Member Zuber expressed support for establishing a subcommittee. Member Clyde expressed the opinion that the subcommittee should be well-rounded and representative of all concerned citizens and agencies. Vice Chairperson Yanuck responded to questions regarding the purpose of this agenda item, and discussion took place regarding the Commission's role to appoint members and establish the purview of the subcommittee. In response to a question, Member Zuber reviewed the BLM designation policies for off-road vehicles, and provided historic information on their origin. (1-1542) Bob McCulloch requested the Board to recommend to the Wildlife Commission that they allow the county game boards to recommend the subcommittee members. **Member Clyde moved to recommend to the Wildlife Commission to establish a subcommittee and to request each county advisory board to provide recommendations for two members from each county to serve on the subcommittee. Member Derley seconded the motion. Motion carried 4-0.**

9. DISCUSSION OF POINTS OF INTEREST FROM THE APRIL 9, 2004 WILDLIFE COMMISSION MEETING (1-1625) - Vice Chairperson Yanuck referred to the draft Commission minutes, and reviewed statistical information regarding OHV use on BLM and U.S. Forest Service lands. He discussed the importance of integrating proposals for OHV use with those of the BLM and the USFS. Member Zuber expressed a preference that NDOW address OHV policies rather than the Department of Motor Vehicles or Nevada State Parks. In response to a question, Vice Chairperson Yanuck reviewed information provided at the Commission meeting on the wild horse and burro management issues. Robert Abbey, of the BLM, reported that additional funding and reallocation of existing funding had been requested but that he did not anticipate receiving the funding. Bob Vaught, of the USFS, advised that the USFS relies on the BLM for wild horse and burro management. Member Zuber advised that reallocation of BLM funds is still a possibility. Vice Chairperson Yanuck reported that the petition filed by George Taulman was denied. He further reported that NDOW will be required to approach the legislature for additional funding, and will reopen the issue of including an annual cost of living index on some of the fees rather than having to approach the legislature every other year for additional funding.

10. ADVISORY BOARD TO MANAGE WILDLIFE CONSENT AGENDA. All matters listed under the Consent Agenda are agendized for the May 14 and 15, 2004 Wildlife Commission meeting and may be acted upon by the Advisory Board to Manage Wildlife with one action and without extensive hearing. Any member of the Board or any citizen may request that an item be taken from the consent agenda and acted upon separately during this meeting (1-2072) - Vice Chairperson Yanuck requested to address items 10-C and 10-E separate from the consent agenda. **Member Zuber so moved. Member Derley seconded the motion. Motion carried 4-0.** (1-2284) **Member Derley moved to accept all the items on the consent agenda. Member Clyde seconded the motion. Motion carried 4-0.**

10-E. ACTION REGARDING BOND FUND EXPENDITURE - KELLY CLARK. The Department is requesting Commission concurrence to use \$50,000 from 1991 Parks and Recreation Question 5 bond funds to install a fire protection system at the Verdi Nature Center and to purchase signs acknowledging voters and the Question 5 Initiative at 40 sites statewide (1-2238) - Vice Chairperson Yanuck expressed concern with regard to the lack of information provided for this item. 10-H. ACTION REGARDING COUNTY ADVISORY BOARDS TO MANAGE WILDLIFE BUDGET - DAVE HANSEN. The 17 counties have been polled regarding travel and operating funds needed from the state wildlife account for fiscal year 2005. In accordance with NRS 501.320, the Commission will vote to approve fund transfers to the County Advisory Boards to Manage Wildlife budgets.

REPORT ON GOVERNOR'S SAGE GROUSE CONSERVATION PLAN - GIL YANUCK (1-2382) - Vice Chairperson Yanuck circulated the most recent draft of the Sage Grouse Conservation Plan, and advised that a bi-state meeting was scheduled for later in the week. He referred to comments which have recently appeared in local newspaper articles regarding the possible listing of sage grouse. He advised that Nevada is generally doing everything possible according to the program. He commented that participating in this project over the past three years has been "an experience." He expressed the hope that the U.S. Fish and Wildlife Service will favorably consider the State's conservation plan and act accordingly. He advised that some of the action plans to improve habitat and increase sage grouse population will be implemented this year. He further advised that the annual sage grouse symposium will include action plan reports.

13. REPORT REGARDING THE FY2003/2004 CARSON CITY ADVISORY BOARD TO MANAGE WILDLIFE BUDGET (1-2462) - Vice Chairperson Yanuck provided background information on and emphasized the importance of submitting reimbursement requests in a timely manner. He advised that sufficient funds are available to finish out the fiscal year.
