

**Liquor Hearing Officer
Minutes of the November 29, 2022 Meeting

A Liquor Hearing Officer meeting was scheduled for 9:00 a.m. on Tuesday, November 29, 2022, in the Carson City Community Development Conference Room A, 108 East Proctor Street, Carson City, Nevada.

1. CALL TO ORDER

Ms. Sullivan called the meeting to order at 9:00 a.m.

2. MODIFICATION TO THE AGENDA

Ms. Kiel noted that there were no modifications to the agenda.

3. PUBLIC COMMENT

None.

4. ACTION ITEMS

4.A FOR POSSIBLE ACTION: DISCUSSION AND POSSIBLE ACTION REGARDING AN APPLICATION FOR A TAVERN/BAR LIQUOR LICENSE (LIQUOR-007547-2022) WITH AARON CRAIG ORLICK AND BRANDY LYNN ORLICK AS LIQUOR MANAGERS FOR A & B MANAGEMENT, LLC DBA JIMMY G'S CIGAR BAR LOCATED AT 301 N CARSON STREET, CARSON CITY, NV 89701.

Ms. Sullivan introduced the item, and Ms. Kiel indicated that there were no changes to the Memorandum, which is incorporated into the record.

The Applicants, Aaron Craig Orlick and Brandy Lynn Orlick, confirmed they read and agreed to the Conditions of Approval outlined in the Memorandum. Carson City Sheriff's Office Deputy Martha Tschetter indicated that an inspection of the property was conducted, and no issues were observed that would warrant denying the issuance of a liquor license to Mr. Orlick and Ms. Orlick. Deputy Tschetter informed the Applicants that the Sheriff's Office performs alcohol compliance checks, during which minors would attempt to purchase alcohol from the businesses, and the businesses were responsible for establishing reliable identification policies to prevent selling alcohol to minors. She indicated that any individual who transfers or sells alcohol is required to complete a server training course, and if a business fails an alcohol compliance check, the business will be asked for proof of completion of server training. She advised keeping copies of the server training certifications on the premises.

Carson City Health and Human Services (CCHHS) Environmental Health Specialist Kandis Harvey commented that Mr. Orlick and Ms. Orlick had been "more than accommodating for the Health Department."

Ms. Sullivan stated that there has been a lot of trash around the property due to some of the clients from Jimmy G's Cigar Bar, and the previous owners of Jimmy G's Cigar Bar had ensured that the area around Jimmy G's Cigar Bar was clean. Ms. Sullivan requested that Mr. Orlick and Ms. Orlick remain attentive to the trash that may need to be cleaned up between Friday night and Monday.

ACTION: Ms. Sullivan approved an application for a Tavern/Bar Liquor License with Aaron Craig Orlick and Brandy Lynn Orlick as Liquor Managers for A & B Management, LLC dba Jimmy G's Cigar Bar at 301 North Carson Street, Carson City, Nevada 89701 subject to the following conditions of approval:

- The Applicant must sign a sworn affidavit consistent with Carson City Municipal Code (CCMC) 4.13.060 regarding a server training course.
- Alcohol sold must come from approved sources.
- The holder of the liquor license must maintain on the premises, evidence of employee server training certification for all employees that serve or sell alcohol.

4.B FOR POSSIBLE ACTION: DISCUSSION AND POSSIBLE ACTION REGARDING AN APPLICATION TO REINSTATE AND APPROVE A CHANGE OF LOCATION FOR TAVERN/BAR LIQUOR LICENSE (LIQUOR-004766-2020) WITH GINA ROHRER AS THE LIQUOR MANAGER FOR LIVING THE GOOD LIFE, LLC DBA GINA'S GOOD LIFE MUSIC AND LOUNGE LOCATED AT 507 N CARSON STREET, CARSON CITY, NV 89701.

Ms. Sullivan introduced the item, and Ms. Kiel indicated that there were no changes to the Memorandum, which is incorporated into the record.

The Applicant, Gina Rohrer, confirmed she read and agreed to the Conditions of Approval outlined in the Memorandum. Deputy Tschetter noted that there were no issues observed during the Sheriff's Office inspection of the business.

ACTION: Ms. Sullivan approved an application to reinstate and approve a change of location for a Tavern/Bar Liquor License with Gina Rohrer as the Liquor Manager for Living the Good Life, LLC dba Gina's Good Life Music and Lounge at 507 North Carson Street, Carson City, Nevada 89701 subject to the following Conditions of Approval:

- The Applicant must sign a sworn affidavit consistent with CCMC 4.13.060 regarding a server training course.

- **Alcohol sold must come from approved sources.**
- **The holder of the liquor license must maintain on the premises, evidence of employee server training certification for all employees that serve or sell alcohol.**

4.C FOR POSSIBLE ACTION: DISCUSSION AND POSSIBLE ACTION REGARDING AN APPLICATION FOR A DINING ROOM WITH HARD LIQUOR LICENSE (LIQUOR-007514-2022) WITH HAUKANG CHEN AS THE LIQUOR MANAGER FOR MING'S RESTAURANT LLC LOCATED AT 2330 S CARSON STREET, CARSON CITY, NV 89701.

Ms. Sullivan introduced the item, and Ms. Kiel indicated that there were no changes to the Memorandum, which is incorporated into the record.

The Applicant, Haukang Chen, confirmed he read and agreed to the Conditions of Approval outlined in the Memorandum. Ms. Tschetter noted that no issues were observed during the inspection conducted by the Sheriff's Office at the business, and CCHHS Environmental Health Specialist II Mike Oravetz stated that all the stipulations had been satisfied by the business with food safety management certification and the United States Food and Drug Administration (FDA) Hazard Analysis Critical Control Point (HACCP) food safety program for the business' sushi bar.

ACTION: Ms. Sullivan approved an application for a Dining Room with Hard Liquor License with Haukang Chen as the Liquor Manager for Ming's Restaurant LLC at 2330 South Carson Street, Carson City, Nevada 89701 subject to the following Conditions of Approval:

- **The Applicant must sign a sworn affidavit consistent with CCMC 4.13.060 regarding a server training course.**
- **Alcohol sold must come from approved sources.**
- **The holder of the liquor license must maintain on the premises, evidence of employee server training certification for all employees that serve or sell alcohol.**

5. PUBLIC COMMENT

Ms. Sullivan entertained public comments; however, none were forthcoming.

6. ADJOURNMENT

Ms. Sullivan adjourned the meeting at 9:13 a.m.
