**AGENDA ITEM 4.C:** For Possible Action: Discussion and possible action regarding an application for a Package Liquor License (LIQUOR-007492-2022) with Arturo De Jesus Estrada-Garcia as the liquor manager for Arturo Estrada (A Sole Proprietorship) dba Panaderia La Barca Meat Market & Deli located at 308 E Winnie Ln, Carson City, NV 89706.

**Recommendation:** Deny the Package Liquor License (LIQUOR-007492-2022) with Arturo De Jesus Estrada-Garcia as the liquor manager for Arturo Estrada (A Sole Proprietorship) dba Panaderia La Barca Meat Market & Deli, at 308 E Winnie Ln, Carson City, NV 89706, based on the finding that the applicant is unsuitable for issuance of a liquor license.

Per Carson City Municipal Code (CCMC) 4.13, all liquor license requests are to be reviewed by the Hearings Officer. The Hearings Officer may grant or deny the application for a liquor license or place conditions on a license to ensure compliance with the Municipal Code.

The subject request is for Arturo Estrada (A Sole Proprietorship) to have a Package Liquor License with Arturo De Jesus Estrada-Garcia as the liquor manager.

Per CCMC 4.13.125(1) the denial of a liquor license must be made based on the finding that an applicant is unsuitable for the issuance of a liquor license and CCMC 4.13.125(2) provides guidance as to who is unsuitable for a license.

The Sheriff's Office began the background investigation on Mr. Estrada-Garcia in September of 2022. On December 8, 2022, the Sheriff's Office issued a memorandum informing the Business License Division that the Sheriff does not recommend approval for a liquor license. The applicant was unable to provide the last names of his parent and step-parent of whom operate the store on a full-time basis. Mr. Estrada-Garcia also omitted information on his application pertaining to one arrest and a criminal complaint.



The Sheriff's Office has conducted a background investigation on the above applicant for a liquor license and has found the following

- **Background of premises:** Panaderia La Barca Meat Market & Deli is located at 308 E. Winnie Ln and previously operated as El Torito. There have been minimal calls for service to this location since 2018. A business check of the location was performed by the Sheriff's Office on October 20, 2022.
- **Financial arrangements:** Mr. Estrada-Garcia is the sole proprietor and the financial investment of \$70,000 was being paid by Mr. Estrada-Garcia's father.
- **Method of operation:** Panaderia La Barca operates as a bakery, meat market and deli with plans to sell bottled beer if approved for a liquor license. The market is open daily and is operated on a full-time-basis by Mr. Estrada-Garcia's father, Arturo, and his stepmother Isabelle. Mr. Estrada was not able to furnish his stepmothers last name nor his father's complete last name. Mr. Estrada-Garcia is employed full time elsewhere and indicated that he would be at the deli at the end of his regular workday.
- **Results of background:** The background for Arturo Estrada-Garcia consisting of DMV records, various agency checks, Nevada criminal history, credit report and fingerprint responses did not find any disqualifying factors as defined in CCMC 4.13.125 2(a). However, Mr. Estrada omitted information from his application pertaining to one arrest and a criminal complaint which was filed against him but where charges were not filed. When I asked Mr. Estrada about those incident's he informed me he omitted the arrest because he was a juvenile at the time and the other because someone else completed the applications for him even though he signed them.
