**1.        CALL TO ORDER AND DETERMINATION OF QUORUM**

**2.        PLEDGE OF ALLEGIANCE**

(5:30:38) – Led by Chairperson Thompson.

**3.        PUBLIC COMMENT**

(5:31:00) – Chairperson Thompson entertained public comments; however, none were forthcoming.

**4.        FOR POSSIBLE ACTION: APPROVAL OF MINUTES – OCTOBER 31, 2022**

(5:31:24) – Chairperson Thompson introduced the item and entertained a motion.

**(3:31:38) – Member Boehmer moved to approve the minutes from the October 31, 2022 meeting as presented. The motion was seconded by Member Wilson and carried 4-0-0.**

**5. FOR INFORMATION ONLY: UPDATE AND ACTIVITY REPORT ON THE CARSON CITY URBAN WILDLIFE COMMITTEE.**

(5:31:57) – Chairperson Thompson introduced the item. Member Boehmer stated that he had contacted the Nevada Department of Wildlife (NDOW), as NDOW had appointed a new Urban Wildlife Coordinator for Northern Nevada, and Member Boehmer discussed having a week or a month dedicated to promoting education and communication about the City’s urban wildlife. He noted that the Urban Wildlife Coordinator was “all for it” and would review previous urban wildlife campaigns. Additionally, the Urban Wildlife Coordinator’s idea was to develop a weeklong worth of webinars to engage members of the public that would also be promoted in Carson City. Member Boehmer briefly informed Mayor Lori Bagwell about the proposed urban wildlife campaign, and if Mayor Bagwell was in favor of the campaign, Member Boehmer would develop a presentation to present to the Carson City Board of Supervisors (BOS) for the purpose of issuing a formal declaration to recognize a week or a month for urban wildlife. He mentioned that there were songbirds in Nevada that typically travel through the area; however, those songbirds had been lingering in Nevada, which provided some “great” birding opportunities. Member Boehmer also had the opportunity to participate in the Sheep Show Youth Experience, which was a coordination effort with the Sheep Show in Reno, and Member Boehmer was assigned to teach duck calling to those participating in the event. He commented that the Sheep Show Youth Experience was “a lot of fun,” and approximately over 1,000 duck calls were distributed to participants. Member Boehmer was also asked to return to the Sheep Show Youth Experience along with any other WAB Members he wished to invite to the event. Another Sheep Show Youth Experience event would take place at the Capitol City Gun Club during the summer of 2023.

(5:36:16) – Chairperson Thompson added that the local deer may appear to be struggling due to the current weather conditions; however, it was important to not try to feed the deer, as their stomachs adjust to the time of year, and grasses or hay could cause health problems or death for the deer. He also mentioned that, based on a discussion with NDOW Wildlife Biologist Carl Lackey, three mountain lions had been “chased off” from two “kill sites” in the Timberline area, and there had not been reports of any other mountain lion sightings in the area since those occurrences.

FOR POSSIBLE ACTION: DISCUSSION AND POSSIBLE ACTION TO MAKE RECOMMENDATIONS TO THE NEVADA BOARD OF WILDLIFE COMMISSIONERS REGARDING COMMISSION REGULATION 23-13, MIGRATORY GAME BIRD SEASONS, BAG LIMITS, AND SPECIAL REGULATIONS FOR WATERFOWL AND WEBLESS MIGRATORY GAME BIRDS PUBLIC HUNTING LIMITED ON WILDLIFE MANAGEMENT AREAS AND DESIGNATED STATE LANDS – 2023 – 2024 SEASON.** *At its March 11, 2023 meeting, the Nevada Board of Wildlife Commissioners will consider recommendations for seasons, bag limits and special regulations for migratory game birds for the 2023-2024 season and adopt regulations consistent with proposed regulations framework for the 2023-2024 hunting seasons on certain migratory game birds established by the U.S. Fish and Wildlife Service. The Commission will also consider rules regulating public hunting on Wildlife Management Areas and designated state lands.*
