AGENDA ITEM 4.B: For Possible Action: Discussion and possible action regarding an application for a Dining Room with Beer/Wine liquor license (LIQUOR-008003-2023) with Dilraj Kaur as the liquor manager for DAYAMEHAR2 LLC dba Flat Earth Pizza located at 2010 E William Street, Carson City, NV 89701.

Recommendation: To approve an application for a Dining Room with Beer/Wine Liquor License with Dilraj Kaur as the liquor manager for DAYAMEHAR2 LLC dba Flat Earth Pizza at 2010 E William St, Carson City, NV 89701 subject to the following approval:

1. The applicant must sign a sworn affidavit consistent with Carson City Municipal Code (CCMC) 4.13.060 regarding a server training course.
2. The holder of the liquor license must maintain on the premises, evidence of employee server training certification for all employees that serve or sell alcohol.

Per Carson City Municipal Code (CCMC) 4.13, all liquor license requests are to be reviewed by the Hearings Officer. The Hearings Officer may grant or deny the application for a liquor license or place conditions on a license to ensure compliance with the Municipal Code.

The subject request is for DAYAMEHAR2 LLC dba Flat Earth Pizza to have a Dining Room with Beer/Wine Liquor License with Dilraj Kaur as the liquor manager.

The Sheriff's Office did a background investigation and did not find any disqualifying information based on CCMC 4.13.125.

This request has been reviewed by the Health Department. The Health Department inspected the premises and is recommending approval. Comments provided by the Health Department in the attached memo have been incorporated as conditions of approval where appropriate.



The Sheriff's Office has conducted a background investigation on the above applicant for a liquor license and has found the following:

- Background of premises: Flat Earth Pizza is located at 2010 E William St. and was recently purchased by Dilraj Kaur. The location will operate under her ownership on May 15, 2023. This business had previously operated as Thick Slice Pizza before the name was changed.
- Financial arrangements: Dilraj Kaur is investing approximately \$75,000 of personal monies for the purchase of the business and startup costs. She also has a triple net lease agreement for the property.
- Method of operation: Flat Earth Pizza will be open daily, with delivery service, serving pizza and other menu items as well as beer and wine. The location will employ up to ten persons and Ms. Kaur will be working in the restaurant full time. Ms. Kaur anticipates having 3-4 gaming machines onsite in the future.
- Results of backgrounds: The background for Dilraj Kaur consisting of DMV records, Nevada criminal history record, fingerprint responses and credit report did not find any disqualifying factors based on CCMC 4.13.125.
