AGENDA ITEM 4.D: For Possible Action: Discussion and possible action regarding an application to add Jillian Kaye Rush as an additional liquor manager to Liquor License (LIQUOR-004702-2020) Dolgen Midwest, LLC dba Dollar General Store #14780 located at 3059 Hwy 50 E, Carson City, NV 89701.

Recommendation: To approve an application to add Jillian Kaye Rush as an additional liquor manager to the existing Liquor License for Dolgen Midwest, LLC dba Dollar General Store #14780 at 3059 Hwy 50 E, Carson City, NV 89701 subject to the following approval:

1. The applicant must sign a sworn affidavit consistent with Carson City Municipal Code (CCMC) 4.13.060 regarding a server training course.
2. The holder of the liquor license must maintain on the premises, evidence of employee server training certification for all employees that serve or sell alcohol.

Per Carson City Municipal Code (CCMC) 4.13, all liquor license requests are to be reviewed by the Hearings Officer. The Hearings Officer may grant or deny the application for a liquor license or place conditions on a license to ensure compliance with the Municipal Code.

The subject request is for Dolgen Midwest, LLC dba Dollar General Store #14780 to have an additional liquor manager for liquor license LIQUOR-004702-2020.

The Sheriff's Office did a background investigation on Ms. Jillian Rush and did not find any disqualifying information based on CCMC 4.13.125. Gary Johnson, current liquor manager, will remain as a liquor manager on the liquor license as well.

It was not applicable to have the health department review the application for an additional liquor manager.



The Sheriff's Office has conducted a background investigation on the above applicant and has found the following:

- Background of premises: Dollar General is located at 3059 Highway 50 E and has been open for business since 2014. Since the stores opening, there have been minimal calls for service to this location, mostly pertaining to fraud or petty larceny.
- Financial arrangements: Ms. Rush is employed as a District Manager for Dollar General and has no financial interest in the business. She is applying as a second liquor manager.
- Method of operation: Dollar General is a retail store selling groceries and a variety of household products, as well as packaged beer and wine. The store is open daily and employs seven persons and has a store manager on site. Ms. Rush is the District Manager for nine stores in five counties and makes visits to each location.
- Results of backgrounds: The background for Jillian Rush did not find any disqualifying events as listed in CCMC 4.13.125. However, Ms. Rush failed to list all arrests on her application.


