AGENDA ITEM 4.E: For Possible Action: Discussion and possible action regarding an application for a Dining Room with Hard Liquor License (LIQUOR-007976-2023) with Daniel Dunbar as the liquor manager for Homegrown Bowling LLC dba HomeGrown Bowl, Bar Grill and Billards located at 4600 Snyder Ave, Carson City, NV 89701.

Recommendation: To deny an application for a Dining Room with Hard Liquor License with Daniel Dunbar as the liquor manager for Homegrown Bowling LLC dba HomeGrown Bowl, Bar Grill and Billards at 4600 Snyder Ave, Carson City, NV 89701 based on the finding that the applicant is unsuitable for the issuance of a liquor license as outlined in the 6/13/2023 memo from the Sheriff's Office.

Per Carson City Municipal Code (CCMC) 4.13, all liquor license requests are to be reviewed by the Hearings Officer. The Hearings Officer may grant or deny the application for a liquor license or place conditions on a license to ensure compliance with the Municipal Code. Per CCMC 4.13.125(1) the denial of a liquor license must be made based on the finding that an applicant is unsuitable for the issuance of a liquor license.

The subject request is for Homegrown Bowling LLC to have a Dining Room with Hard Liquor License with Daniel Dunbar as the liquor manager.

The Sheriff's Office did a background investigation on Daniel Dunbar and did not find information that would disqualify him for issuance of a liquor license; however, Mr. Dunbar was caught selling alcohol without a liquor license or management agreement with the previous owners. Additionally, Mr. Dunbar was operating without a business license.

This request has been reviewed by the Health Department. The Health Department inspected the premises. Should this application be approved, the comments included in the memo should be reviewed and incorporated as conditions of the liquor license as appropriate.

RULES & REGULATIONS REGARDING LIQUOR LICENSES

I/we, Daniel A. Dunbar, _____, _____

 _____, the undersigned, understand that:

- I/we cannot sell alcohol until the Carson City Liquor Board, consisting of the Board of Supervisors and the Carson City Sheriff, approves my/our liquor license OR there is a temporary management agreement with the present owner of the establishment (who has a valid liquor license) on file with the Carson City Business License Division.
- I/we may not take control of or transfer ownership of said business before my/our liquor license is approved OR a management agreement is on file with the Carson City Business License Division.
- Taking control of or transferring ownership of said business before my/our liquor license is approved could hinder my/our chances of getting a liquor license.
- If any changes are made after completing said liquor license application (i.e., change of business name, location, nature of business, partner or corporate officer change, etc.) the Carson City Business License Division MUST be notified and a new liquor license application MUST be completed BEFORE the change occurs.
- If I am/we are issued a liquor license, the fees for said liquor license MUST be paid on or before the 1st day of July. If the annual liquor license fees are not paid by the 1st day of July, a 50% penalty charge will be assessed, without exception, and this delinquency becomes grounds for revocation of the liquor license.
- I/we also understand that if my/our liquor license is revoked by the Liquor Board, I/we cannot reapply for a new liquor license for 6 (six) months from the date of the board's action. I/we also understand that after reapplying, I/we MUST have the unanimous approval of all members of the Liquor Board.
- A liquor license is issued to a given owner at a specific location and is non-transferable to a different owner or different location. A new liquor license application must be filed for ANY change.
- The application fee and the investigation fee, paid at the time of application for a liquor license, are non-refundable.

I/We have read and fully understand the above and have received a copy thereof.

The Sheriff's Office has conducted a background investigation on the above applicant for a liquor license and has found the following:

- Background of premises: Home Grown Bowling is located at 4600 Snyder Ave. and previously operated as Carson Lanes. Mr. Dunbar and his wife are the new business owners and will operate the location as Homegrown Bowl, Bar, Grill & Billiards.
- Financial arrangements: The Dunbar's are not investing any money and have a triple net lease agreement for the facility, plus utilities.
- Method of operation: Homegrown Bowl, Bar, Grill & Billiards is open daily and consists of a bowling alley, billiards room and a bar and grill with seating. The location employs five persons and Mr. Dunbar will be onsite managing the business. Mr. Dunbar has applied for the selling of beer, wine, and hard liquor.
- Results of backgrounds: The background for Daniel Dunbar consisting of DMV records, Nevada criminal history record, and credit report did not find any disqualifying factors based on CCMC 4.13.125. However, on June 12, 2023, Mr. Dunbar was caught selling alcohol without a liquor license and he does not have a management agreement with the previous licensee. A crime report was initiated

which will be submitted to the DA for selling/providing liquor without a liquor license. On June 13, 2023, I also spoke with the Carson City Business License office who informed me that Mr. Dunbar still has not yet obtained his business license, as of June 13, 2023.
