## **I. CALL TO ORDER - ROLL CALL**

(00:01) – Chairperson Knight called the meeting to order at 5:30 p.m. Roll was called; a quorum was present. Trustee Beth Lucas was absent from this meeting.

## **II. PUBLIC COMMENT**

(00:32) – Chairperson Knight entertained public comments; however, none were forthcoming.

## **III. FOR POSSIBLE ACTION – APPROVAL OF MINUTES OF PREVIOUS MEETING**

### **III.a. FOR POSSIBLE ACTION – APPROVAL OF MINUTES OF PREVIOUS MEETING (AUGUST 10, 2023).**

(01:03) – Chairperson Knight introduced the item and entertained changes, comments, and a motion.

**(01:20) – MOTION:** Vice Chairperson Olivas moved to approve the August 10, 2023 meeting minutes as presented. Trustee Markle seconded the motion. The motion carried 3-0-1 with Chairperson Knight abstaining, as she was not present during the August 10, 2023 meeting.

## **IV. FOR POSSIBLE ACTION - LIBRARY BOARD OF TRUSTEE BUSINESS**

### **IV.a. FOR POSSIBLE ACTION - DISCUSSION AND POSSIBLE ACTION REGARDING BOOK TITLES FOR A PROPOSED MURAL IMAGE ON THE LIBRARY BUILDING AS PART OF THE “MURALS AND MUSIC” PROJECT, AND DIRECTION TO STAFF REGARDING THE BOOK TITLE SELECTION PROCESS.**

(01:45) – Chairperson Knight introduced the item. Ms. Holt presented an update on the “Music and Murals” project.

(03:01) – Ms. Holt said the project was approved by the Public Art Panel and would be presented to the Board of Supervisors on Thursday, September 21 for final approval. Ms. Holt added that the mural would be located on the short wall facing Roop Street on the East side of the Library since the area is protected by an overhang which could help mitigate potential damage from exposure to outdoor elements.

(06:10) – Ms. Holt suggested that the mural display book genres instead of book titles due to concerns over potentially controversial book titles.

(10:38) – Trustee Markle stated that displaying genres instead of book titles was “wimping out.” Trustee Nichols agreed with Trustee Markle, referring to the decision as “a cop out.”

(12:24) – Chairperson Knight commented that selecting controversial book titles could detract from the Library’s Strategic Plan and favored displaying genres that patrons are interested in.

(13:55) – Ms. Holt said she didn’t want the mural to interfere with the Library’s positive trajectory.

(14:23) – Chairperson Knight stated that displaying genres would be a better long-term decision since book genres don’t change.

(18:05) – Trustee Nichols said she believed being afraid to “stir anything up” could harm the library. Chairperson Knight commented that displaying book genres would be a promotional opportunity rather than “kowtowing” to show patrons what genres can be found at the library.

(18:54) – Trustee Markle stated that art is “supposed to make people think.” She added that she believes there are books that are representative of the community.

(24:47) – Ms. Holt said she was concerned with the safety of Library staff because libraries in surrounding areas have dealt with disconcerting situations.

(27:20) – Based on Library staff recommendations, Ms. Holt suggested that the mural display Nevada history, romance, westerns, science fiction, mystery, cooking, and “Español.”

(30:38) – Chairperson Knight suggested adding Children’s literature to the list of displayed book genres.

(33:35) – Trustee Nichols said mystery should be removed from the list because it’s obvious that the Library carries the genre. She also suggested removing romance.

(35:19) – Vice Chair Olivas commented that “Español” isn’t an actual genre, but a language. Ms. Holt asked for suggestions to show that the Library has a large selection of books in Spanish.

(35:43) – Chairperson Knight suggested displaying the book genres in both English and Spanish. Vice Chair Olivas suggested only having three book genres in English and Spanish, instead of all of them.

(41:04) – Ms. Holt confirmed that the mural would display eight genres including Nevada history, westerns, science fiction, cooking/gardening, biographies, and poetry. Additionally, children’s books and technology displayed in both English and Spanish.

(42:22) – Trustee Nichols suggested that all eight of the genres should be displayed in both English and Spanish. Ms. Holt said she would speak to the artist to determine what fits best.

**(46:33) – MOTION:** Trustee Nichols moved to approve the following genres for the Library mural: Nevada history, displayed in both English and Spanish, westerns, science fiction, cooking/gardening, biographies, poetry, children's Books, displayed in English and Spanish, and technology, displayed in English and Spanish, "as long as the artist can fit all of these on, if not the Library Director can choose from the list." Vice Chair Olivas seconded the motion. The motion carried 3-0-1 with Trustee Markle abstaining.
