The Applicant, William White, said he had read and agreed with the Conditions of Approval listed in the Memorandum.

Ms. Sullivan noted that the Administrative Citation involved an employee selling alcohol to a minor on September 21, 2023. Mr. White stated that the employee was new and didn't verify the individual's identification card (ID). Mr. White stated that the employee is no longer in a position where she sells alcohol.

Ms. Kiel noted that this was the second citation administered to Smith's in the last 12 months. She added that if the store received three citations in 12 months, the administrative fine would reach \$1,000 and the liquor license would be suspended or revoked.

- **The Liquor Catering License scope includes privately catered events, service for public events will still require a Special Event Temporary Liquor permit where appropriate per CCMC 4.13. 240.**

4.H FOR POSSIBLE ACTION: DISCUSSION AND POSSIBLE ACTION REGARDING AN APPLICATION FOR A COMBINATION PACKAGE AND “ON PREMISE” LIQUOR LICENSE (LIQUOR-008148-2023) WITH CANDICE TURNER AS THE LIQUOR MANAGER LONGSTRAW, LLC DBA THE WALK-UP LOCATED AT 318 N CARSON ST #213, CARSON CITY, NV 89701.

Ms. Sullivan introduced the item. Ms. Kiel indicated that there were no changes to the Memorandum, which is incorporated into the record.

Ms. Sullivan introduced the item and noted that this is the third citation M & J Family LLC had received in the last 12 months. Obaid R Mobaligh, representing M & J LLC, stated that he was unaware of the first two citations. Mr. Mobaligh added that disciplinary action was taken and the store now has an area manager to oversee training.

ACTION: Ms. Sullivan issued a fine of up to \$1,000 to be paid within 30 days and suspended the liquor license for seven days.

Ms. Sullivan entertained public comments; however, none were forthcoming.

6. FOR POSSIBLE ACTION: ADJOURNMENT

Ms. Sullivan adjourned the meeting at 1:51 p.m.
