**AGENDA ITEM 4.D: For Possible Action: Discussion and possible action regarding clarification on a Notice of Decision to change the liquor manager on Wholesale Distributor liquor license (LIQUOR-004866-2020) with Steven R Becker as the liquor manager for Southern Glazer's Wine and Spirits, LLC located at 8400 S Jones Blvd, Las Vegas, NV 89139.**

**Recommendation:** To approve a change of liquor manager for a Wholesale Liquor Distributor liquor license with Steven R Becker as the liquor manager and exempt Mr. Becker from the previous condition of approval to sign a sworn affidavit for Southern Glazer's Wine and Spirits, LLC located at 8400 S Jones Blvd, Las Vegas, NV 89139 subject to the following approval:

1. The applicant must maintain a valid liquor license, of which they are also the liquor manager of said license, in the county where the primary business is located.

Per Carson City Municipal Code (CCMC) 4.13, all liquor license requests are to be reviewed by the Hearings Officer. The Hearings Officer may grant or deny the application for a liquor license or place conditions on a license to ensure compliance with the Municipal Code.

The subject request is for Southern Glazer's Wine and Spirits, LLC to have a Wholesale Liquor License with Steven R Becker as the liquor manager. The applicant is exempt from the requirement to sign a sworn affidavit stating that all employees will complete a server training course. According to NRS 369.610, the training is designed to, "educate persons who sell or serve alcoholic beverages or perform the duties of a security guard at an establishment" and under NRS 369.620, the term, "Establishment" does not include a wholesale dealer.

The General Wholesale License is also exempt from a Carson City Sheriff's Office background investigation because the business is compliant with the exemption stated in CCMC 4.13.070 2. Steven R Becker has provided proof of a valid liquor license in Washoe County and the applicant is also the liquor manager of said license, in the county where the primary business is located.
