The Northern Nevada DUI Task Force provides Victim Impact Panels (VIP) to anyone ordered to attend. These panels are provided twice a month with one on Zoom and one in person. The in-person panel is held at the Washoe County Commissioners Chambers located at 1001 E. 9th Street, Reno, NV 89502.

For those who require Spanish speaking, we will have an interpreter who will manage and present the Spanish Victim Impact Panel. They will only be available in person at the Washoe County Commissioners Chambers and only on the Reno dates.

If you are planning to attend the in-person panel, you DO NOT need to pre-register and can show up the night of the panel. Following are the dates and times:

RENO – IN-PERSON (ENGLISH AND SPANISH SPEAKING PANELS)

Registration starts at 6:00 p.m. and the VIP goes from 7:00 p.m. to 8:30 a.m. The doors close promptly at 7:00 p.m., so do NOT be late or you will not be allowed into the VIP.
