RESOLUTION No.: 2025-R-4

A RESOLUTION ESTABLISHING THE TERMS AND CONDITIONS FOR THE CARSON CITY FIRE DEPARTMENT'S OUT-OF-JURISDICTION RESPONSE FOR EMERGENCY INCIDENT ASSIGNMENT.

WHEREAS, Carson City is a consolidated municipality and political subdivision of the State of Nevada; and

WHEREAS, Carson City provides fire and other emergency response through its Fire Department; and

WHEREAS, it is the Carson City Fire Department's desire to provide fair and legal payment to all its employees for time worked, including during out-of-jurisdiction response to emergency incidents; and

WHEREAS, the Carson City Fire Department has in its employ, Fire Department response personnel which include the following positions: Fire Chief, Deputy Chief, Deputy Emergency Manager, Battalion Chief, Fire Captain, Firefighter/Paramedic, Firefighter, Driver Operator, Fire Prevention Inspector, Wildland Fuels Crew Boss, Wildland Crew Member and Wildland Equipment Operator; and

WHEREAS, the Agreement for Local Government Fire and Emergency Assistance to the State of California and Federal Fire Agencies ("Agreement") requires a Governing Body Resolution concerning the Carson City Fire Department's pay practices to ensure that the Carson City Fire Department is reimbursed, consistent with its pay practices, for Carson City Fire Department personnel assigned to an out-of-jurisdiction emergency incident under the Agreement; and

WHEREAS, the Carson City Fire Department will compensate its employees portal to portal while in the course of their employment and away from their official duty station and assigned to an emergency incident, in support of an emergency incident or pre-positioned for emergency response; and

WHEREAS, the Carson City Fire Department will compensate its employees overtime in accordance with their current Collective Bargaining Agreements while in the course of their employment and away from their official duty station and assigned to an emergency incident, in support of an emergency incident or pre-positioned for emergency response.

NOW, THEREFORE, BE IT RESOLVED, by the Carson City Board of Supervisors that:

1. Carson City Fire Department personnel responding under the Agreement shall be compensated according to current Collective Bargaining Agreements, Personnel Rules and Regulations and/or other directive that identifies personnel compensation in the


workplace.

2. In the event a personnel classification does not have an assigned compensation rate, a "base rate" as set forth in an organizational policy, administrative directive or similar document will be used to compensate such personnel.
3. The Carson City Fire Department will maintain a current salary survey or acknowledgement of acceptance of the "base rate" on file with the California Governor's Office of Emergency Services, Fire Rescue Division.
4. Personnel will be compensated, portal to portal, beginning at the time of dispatch to an out-of-jurisdiction emergency incident and ending upon return to original jurisdiction when equipment and personnel are in service and available for out-of-jurisdiction emergency response response.
5. Carson City Fire Department response personnel include the following positions: Fire Chief, Deputy Chief, Deputy Emergency Manager, Battalion Chief, Fire Captain, Firefighter/Paramedic, Firefighter, Driver Operator, Fire Prevention Inspector, Wildland Fuels Crew Boss, Wildland Crew Member and Wildland Equipment Operator

BE IT FURTHER RESOLVED, and hereby ordered that this resolution be recorded in the office of the Carson City Clerk-Recorder.


