Redemption may be made by payment of the taxes and accruing taxes, penalties and costs, together with interest on the taxes at the rate of ten percent (10%) per annum from date due until paid, as provided by law. Such redemption may be made in accordance with the provisions of Chapter 21 of the Nevada Revised Statutes in regard to real property held APN ASSESSED OWNER under execution.
