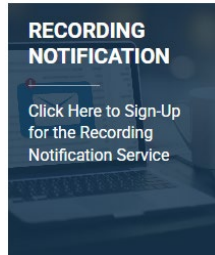


How to sign up for the Recording Notification Service

You must have:

- Internet access (home PC, smartphone, public access, etc.)
- Email address (this is the only way to receive a notification. You will receive a confirmation email. If you do not receive one, please check your junk folder.)
- The format in which your name or Assessor's Parcel Number is indexed **with the Recorder's Office**

1. Go to: www.Carson.org/notification
2. Select this icon:



3. In the Registration screen select whether you are signing up to be notified about a personal or business name. (If you are signing up to be notified when something is recorded under your APN, select **Business.**)
4. Enter the name or APN you wish to monitor and the email address where you would like to be notified. **You MUST use the same format the Recorder's Office uses, which may be different from the one used by the Assessor.** If you are unsure how you are indexed with the Recorder, you can search for recordings under your name/APN at www.carson.org/recorder and note how your name appears (including any middle names or initials, suffixes, etc.). Sign up for the notification exactly as shown. (Ex: If you are indexed as "Jones, John F" and you wish to be notified if anything is recorded using your name, then you will sign up for notifications as "John F" in the first name field and "Jones" in the last name field.)

IF YOUR PROPERTY IS HELD IN A TRUST, IT IS IMPERATIVE THAT YOU SIGN UP UNDER THE TRUST NAME AS INDEXED IN THE RECORDER'S WEBSITE. FOLLOW THE SEARCH INSTRUCTIONS ON THE RECORDER'S WEBSITE TO VERIFY HOW THE TRUST NAME IS INDEXED.

For notifications by **APN, use the Recorder's Format:**

Assessor:

APN 001-234-56

Recorder:

APN 123456

*****If you do not sign up exactly as you are indexed, you will not be notified.*****

Please be aware that the Recorder's Office staff is unable to verify for you how you are indexed. Please do your due diligence to ensure you are signing up properly. The Recorder's Office staff cannot register you on your behalf.

This service does not prevent documents from being recorded against your property; it only notifies you when recordings occur. If you suspect an illegitimate or fraudulent recording, we recommend contacting legal counsel.

Recording Notification Sign-up Instructions

- Please see the attachments on how to sign up for the notification with your Name, Trust, APN, and Business.
- Keep in mind that you have to sign up the same way your document is indexed. Go to the **Recorder website**, view your document, see how we indexed it and sign up the exact same way.
- **Please note that if you change your email you will have to sign up again.**
