## **RANDOM DRUG AND ALCOHOL TESTING NUMBER: (775) 297-8401**

You were assigned to Random Drug and/or Alcohol testing. The following rules & guidelines outline the routine testing procedures. Make sure to read each condition below & ask any questions that you may have.

It is your responsibility to call (775) 297-8401 no later than 8 am, seven (7) days a week (including weekends & holidays). You will be prompted to enter your individualized pin and follow the instructions. Please listen to the entire message. If the message states that you are required to test then you must report to the "Testing Site" listed above for testing. You are required to report for testing the same day during the designated testing hours.

You must have a valid government ID (Driver's License, State ID Card or Passport) & you must bring it to every test.

You have been advised that you are not to Consume or Possess Alcohol or Drugs or Drug Paraphernalia, **you are not** allowed to take **narcotic or addictive** medication, unless the medication has been pre-approved by DAS. In order to take these medications, you must provide a letter from your physician stating it is a "**medical necessity and non-narcotics are not an option**" or supplemental provider verification is needed. "Spice" or any synthetic cannabinoids and bath salts (kratom, cathinones, mephedrone, MDPV) are not allowed. Do not consume items containing poppy seeds. **Prescription re-fills have to be re-approved by DAS. Use of Marijuana and/or Medical Marijuana is not allowed at any time while on probation unless a Judge has given permission.**

If you miss your test date, for any reason, you may not be permitted to make up your test on another date & your testing could be extended. You must report to our office the next business day. The only acceptable reason for a No-Show would be a medical emergency which you can verify the missed test with hospital documentation that covers the entire time of testing.

You will be given ample time to submit an observed sample & at least two (2) opportunities. You may not leave the "Testing Site" after you have arrived for any reason. If you leave without permission from DAS, you will not be granted re-entry & be counted as a No-Show.

If you need to leave the area, then you must contact Alternative Sentencing two weeks prior to your departure. You may be required to make an appointment to install a Drug Detection Patch and/or alcohol monitor. The patch and/or alcohol monitor will be installed by DAS & will not be removed until your return. The cost of the patch is \$60 & must be paid in advance. The cost of the SCRAM is \$15 per day plus a \$25 installation fee; and OSM is \$2 per day. You must be current with your fees to qualify.

Do not consume more than 32oz of fluids within four (4) hours of testing. You should not consume any fluid within two (2) hours of testing. Doing so could result in a dilute test, which is a violation of your conditions.

You will be charged \$30 when you are placed on RDA Testing and a \$2 monthly surcharge. Drug confirmation testing is \$25 per substance confirmed & is required for all drug tests sent out for confirmation if you deny use of a certain substance & the substance is later confirmed.
