20 Plaintiffs Zenaida Dagusen, Republican National Committee, Nevada Republican Party
21 and Donald J. Trump for President 2024 (collectively, "Plaintiffs") filed a Complaint for
22 Declaratory and Injunctive Relief on September 11, 2024. On September 27, 2024, Democratic
23 National Committee and Nevada State Democratic Party (collectively, "Defendants", with
24 "Plaintiffs," the "Parties"), by and through counsel, accepted service of the Complaint and
25 Summons. On October 3, 2024, Defendants filed a Motion to Dismiss Plaintiff's Complaint
26 ("Motion to Dismiss"). Defendant Francisco Aguilar, in his official capacity as Nevada Secretary
27 of State, has not yet appeared in the instant action.

STIPULATION

PLAINTIFFS AND DEFENDANTS HEREBY STIPULATE AS FOLLOWS:

1. The Parties agree and stipulate to the following briefing schedule for the pending Motion to Dismiss:

a. Plaintiffs shall file their response to the Motion to Dismiss on or before October 25, 2024. The response is limited to ten pages pursuant to FJDCR 3.23(b).

b. The Parties further stipulate that Defendants shall have until November 8, 2024 to file their reply brief in support of the Motion to Dismiss. The reply is limited to five pages pursuant to FJDCR 3.23(b).

2. The Parties further agree to electronic service of all documents amongst themselves pursuant to NRCP 5(b)(2)(F), for the duration of this action, at the email addresses listed below, and to this Court's judicial assistant, Julie Harkleroad, at jharkleroad@carson.org. Physical copies must be filed with the Court as soon as practicable thereafter, preferably within two days following the deadline, for scheduled filings, or within two days of submission for all other papers.




ORDER
