On November 26, 2025, Petitioner filed *Vote Solar's Petition for Judicial Review* ("Petition"). This Court previously entered an *Order for Briefing Schedule* in this matter on December 3, 2025. However, that Order for Briefing Schedule was erroneously applied to this case in that it reflected procedures for judicial review under the Nevada Administrative


1 Procedure Act in Chapter 233B of Nevada Revised Statute. This Petition concerns judicial
2 review of purported orders of the Public Utilities Commission of Nevada. As such, NRS
3 703.373 establishes the procedures for judicial review which must be applied in this matter.

4 Therefore, good cause appearing,

5 **IT IS HEREBY ORDERED** that the *Order for Briefing Schedule* filed December 3,
6 2025 is **VACATED**.

7 **IT IS HEREBY FURTHER ORDERED** that subsequent to the expiration of the time
8 for filing a reply memorandum of points and authorities pursuant to NRS 703.373(7), the
9 Petitioner or any party to this proceeding may file a request to submit the matter to the Court for
10 review in accordance with FJDCR 3.11. This is necessary to alert the Court that briefing of *Vote*
11 *Solar's Petition for Judicial Review* has been completed.
