9 The Court has considered the presumption that all courtroom proceedings that are open to  
10 the public are subject to electronic coverage pursuant to SCR 230(2). The Court has also  
11 considered the following factors:

- 12 (a) The impact of coverage upon the right of any party to a fair trial;  
13 (b) The impact of coverage upon the right of privacy of any party or witness;  
14 (c) The impact of coverage upon the safety and well-being of any party, witness or juror;  
15 (d) The likelihood that coverage would distract participants or would detract from the  
16 dignity of the proceedings;  
17 (e) The adequacy of the physical facilities of the court for coverage; and  
18 (f) Any other factor affecting the fair administration of justice.

19 Therefore, good cause appearing;

20 **IT IS HEREBY ORDERED:**

21  The request for electronic mediation coverage is **DENIED** for the following

1 in the proceedings and conduct themselves in a manner that does not interfere with the Court's  
2 orderly performance of its duties.

3 Any electronic coverage equipment must be in place in the courtroom and tested no later  
4 than fifteen (15) minutes before the start of any proceeding and may not be removed from the  
5 courtroom except during a natural break in proceedings.

6 The Court's Judicial Assistant will provide a copy of this order to the parties and their  
7 attorney of record. It shall be the responsibility of counsel to notify their witnesses.
