13 _____ 1. I understand I have been charged with driving or being in actual physical control of a motor vehicle on
14 a highway or on premises to which the public has access in Carson City on the _____ day
15 of _____, 20____, in violation of Nevada Revised Statute 484C.110/Carson City Municipal
16 Code 10.22.020.

17 2. Initial the proper element:

- 18 _____ While under the influence of intoxicating liquor; and/or while having 0.08% or more by weight
19 of alcohol in my blood or breath; and/or while having a concentration of alcohol of .08 or more
20 in blood or breath within 2 hours after driving or being in actual physical control of a vehicle.
21 _____ While under the influence of a controlled substance and/or with an amount of a prohibited
22 substance in my blood or urine that is equal to or greater than that prohibited by law.
23 _____ While under the combined influence of intoxicating liquor and a controlled substance.
24 _____ Having inhaled, ingested, applied or otherwise used any chemical, poison or organic solvent, or
25 any compound or combination of any of these, to a degree which rendered me incapable of
safely driving or exercising actual physical control of a vehicle.

26 **PENALTIES AND RIGHTS:**

27 _____ 3. I understand the State/City must prove the elements in the above paragraph beyond a reasonable doubt.

28 _____ 4. I understand the following possible punishments:

29 **1st OFFENSE** in 7 years - A minimum of 2 days, but not more than 6 months in jail, or not less than 48 hours
30 but not more than 96 hours of community service; a fine of not less than \$400, but not more than \$1,000 and
31 assessments; successful completion of an approved educational course on the abuse of alcohol and controlled
32 substances; attendance at a victim's impact panel; a mandatory alcohol abuse evaluation if the BAC is .18% or
33 more or if the Defendant is under the age of 21; and a 185 day revocation of the Defendant's driver's license by
34 the Department of Motor Vehicles, and will be required to have an interlock device installed in my vehicle
35 pursuant to NRS 483.490 and NRS 484C.460.

36 **2nd OFFENSE** in 7 years - A minimum of 20 days, but not more than 6 months in jail; a fine of not less than
37 \$750 and not more than \$1,000 and assessments; or an equivalent number of hours of community service to pay
38 fines and fees; attendance of a victim's impact panel; a mandatory alcohol abuse evaluation; and revocation of
39 the Defendant's driver's license for a period of one year by the Department of Motor Vehicles, and will be
40 required to have an interlock device installed in my vehicle pursuant to NRS 483.490 and NRS 484C.460; and the
41 registration on each vehicle registered to me or owned by me will be suspended for five days.

42 **3rd OFFENSE** in 7 years - Not less than 1 year, nor more than 6 years in the Nevada State Prison; a fine of not
43 less than \$2,000, but not more than \$5,000 and assessments; and revocation of the Defendant's driver's license
44 for a period of 3 years by the Department of Motor Vehicles; and suspension of the registration on each vehicle
45 registered to me or owned by me for a period of five days. Once a person has been convicted of a felony DUI,
any subsequent DUI will be a category B felony, punishable by 2 to 15 years in prison if convicted.

1 I have addressed the Defendant personally, canvassed the Defendant on the above to
2 include the elements of this offense as supported by the facts, the possible penalties, and
3 the Defendant's constitutional rights and find the plea of:

4 Guilty Nolo Contendere (No Contest) is made voluntarily and with an
5 understanding of the nature of the charge and consequences of the plea and order that
6 such plea be entered into the minutes of the Court.
