**F-1. The planning guidelines have been compared to the various elements of the City's Master Plan, and each one corresponds with the elements which have been adopted. Mr. Sullivan discussed Mr. James' presentation and recommended that it be rescheduled for a special meeting in order that the entire Committee could be in attendance. Discussion ensued with regard to the same, and consensus of the members present was to schedule the special meeting for February 28 or 29, 2000.
